Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. All City departments are hereby authorized on behalf of the City of Pittsburgh to enter, in conjunction with the City's Department of Finance, into a facilities usage agreement or agreements during the 2026 calendar year for the purpose of permitting groups to rent City-owned facilities for recreational and community focused activities, in individual amounts not to exceed Ten Thousand Dollars (\$10,000.00).
