Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 413 of 2025, entitled “Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement or Agreements and amendments thereto with Block & Associates for legal services in connection with a current City construction project, for an amount not-to-exceed Forty Thousand Dollars (\$40,000) over one (1) year” is hereby amended as follows:

Section 1. Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement or agreements and amendments thereto, with Block & Associates for legal services in connection with a current City construction project, by adding an additional Twenty Thousand Dollars (\$20,000), for a new

amount not to exceed Sixty Thousand Dollars (\$60,000.00) over one (1) year, charging to and payable from the following JD Edwards Accounts:
