Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 519 of 2025, entitled “Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement or Agreements thereto with Buchanan, Ingersoll, & Rooney PC for legal consulting services in connection with complex real property litigation and related matters, for an amount not-to-exceed Seventy-Five Thousand Dollars (\$75,000) over one (1) year” is hereby amended as follows:

Section 1. Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement or agreements and amendments thereto, with Buchanan, Ingersoll, & Rooney PC for legal consulting services in connection with complex real property litigation and related matters, by adding an additional Fifty-Five Thousand Dollars (\$55,000), for a new amount not to exceed One Hundred Thirty Thousand Dollars (\$130,000), charging to and payable from the following JD Edwards Accounts:
