Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Professional Services Agreement (s) and / or Contract (s) with Buchanan Ingersoll & Rooney PC for professional consulting services for state government legislative services and providing for the payment of costs thereof not to exceed Three Hundred Two Thousand Four Hundred dollars (\$302,400) over four years, chargeable and payable from the following JD Edwards account (s):
