

# “Pizza Pizza’s Toronto Raptors Game Day Contest” Rules

## DEFINITIONS

“**Contest Sponsor**” means Pizza Pizza, 500 Kipling Avenue, Toronto, ON M8Z 5E5

“**Ontario**” This Contest is open only to legal residents of Ontario 18 years of age and older who live within the province.
