AMENDMENT OF THE BY-LAWS OF CASTLE HARBOUR CONDOMINIUMS

EXPLANATORY STATEMENT: The original Bylaws of CASTLE HARBOUR CONDOMINIUMS were recorded among the Land Records of Anne Arundel County, Maryland in Liber 4216, folios 296 et seq. as Exhibit "N" to the Declaration of CASTLE HARBOUR CONDOMINIUMS, recorded among said Land Records in Liber 4216, folios 267 et seq. on December 1986. The Council of Unit Owners of CASTLE HARBOUR CONDOMINIUMS by the affirmative vote of unit owners having sixty-six and two thirds percent (66 2/3%) or more of the votes of said Council of Unit Owners entitled to be cast and by the affirmative vote of unit owners owning sixty-six and two thirds percent (66 2/3 %) or more of the percentage interests of the common element ownership of said condominium, and as provided in Article X, Section 2 of said Bylaws, now hereby amends its said Bylaws as hereinafter provided.

NOW THEREFORE as of the 26 day of June, 2013 the said Bylaws of CASTLE HARBOUR CONDOMINIUMS are hereby amended as follows:


1. Article X, of the above-described Bylaws of CASTLE HARBOUR CONDOMINIUMS is hereby amended by adding a new Section 2. To read as follows:


Section 2. Leasing.

No portion of a Unit (other than the entire Unit) may be rented, and no transient tenants may be accommodated therein. Any Owner of any Condominium Unit who shall lease such Unit shall, promptly following the execution of any such lease, forward a conformed copy thereof to the Board of Directors. Any such lease shall contain a provision to the effect that the rights of the tenant to use and occupy the Condominium Unit shall be subject to and subordinate in all respect to the provisions of the Declaration and these By-Laws and to such other reasonable rules and regulations relating to the use of the common elements or other "house rules", as the Board of Directors may from time to time promulgate. A copy of the Declaration and these By-Laws and any other "house rules" shall be retained in the leased Condominium Unit.

The foregoing amendment shall take effect immediately.
