Indicadores de Resultados

El presente Tablero de Indicadores del PIDyF 2016-2020 se elabora con fundamento en lo dispuesto en el artículo 11 y 16 de la Ley de Rendición de Cuentas y Fiscalización Superior del Estado de Coahuila de Zaragoza, así como los *Lineamientos para la construcción y diseño de indicadores de desempeño mediante la Metodología de Marco Lógico*, emitidos por el CONAC en 2013.

Un valor agregado de esta herramienta de monitoreo y evaluación es que alinea cada uno de los 26 indicadores del PIDyF a la clasificación programática del presupuesto de egresos del Poder Judicial del Estado de Coahuila de Zaragoza de 2017.

Los indicadores incorporan además la medición de avances porcentuales del valor observado actual con respecto a la línea base, así como el avance de la meta anual sobre la línea base. Asimismo, en aquellos indicadores que tienen como medio de verificación electrónico se adjunta su enlace electrónico.

Un reto superado durante la elaboración de los indicadores conjuntamente con cada unidad administrativa fue establecer metas factibles a lograr. Esto implicó realizar adecuaciones a la definición original del indicador. Por último, aquellos indicadores sin medición se espera que lo sean próximo informe de resultados.


