

PETROKIMIA GRESIK GETS THE FIRST "GOLD RANK" AT ASRRAT 2021

[Petrokimia Gresik](#), an Agroindustry Solutions company and a member of the [Pupuk Indonesia](#) holding, won the " **Gold Rank** " predicate for the application of transparent reporting standards and sustainable business practices, in its inaugural participation in the **2021 Asia Sustainability Reporting Rating (ASRRAT) event** .

Director of Finance and General Affairs of Petrokimia Gresik, Budi Wahyu Soesilo, on Friday (19/11) said that transparency is Petrokimia Gresik's commitment as a responsibility to the community and stakeholders so that they understand the programs that are being run by the company.

"Petrokimia Gresik provides space for stakeholders to be able to access the company's sustainability report," said Soesilo.

As for the latest sustainability report, Petrokimia Gresik carries the title "Great for Indonesia". Where Great is an acronym for the words Growth, Excellence and Worthwhile. The report states that, throughout 2020, Petrokimia Gresik has carried out sustainable performance in the field of conserving resources, namely the total use of water for the production process of 31,917,109 m³, then the energy intensity in the Petrokimia Gresik production process in 2020 reached 3.32 GJ/ton for fertilizer production and 5.7 GJ/ton.

"For this commitment, Petrokimia Gresik has received an award from the Ministry of Environment (KLHK) of the Republic of Indonesia," he said.

Next, the Petrokimia Gresik sustainability report also includes aspects of community development (comdev). Throughout 2020, Petrokimia Gresik has made social investment worth IDR 45.1 billion.

"This fund is also distributed by Petrokimia Gresik to support the government in handling Covid-19, especially Petrokimia Gresik is the Coordinator of the National Disaster Response Task Force for the East Java Region," said Soesilo.

Petrokimia Gresik also distributed Partnership Program funds worth IDR 38.25 billion for 299 partners. Then also distribute the Community Development Program funds worth IDR 6.84 billion. In terms of the value of the Environmental Satisfaction Survey towards the company, it reached 86.53%.

"In this field, the Petrokimia Gresik sustainability report also conveys aspects of work safety, economic aspects, and aspects of human resources," said Soesilo.

Meanwhile, ASRRAT is an award given by the National Center for Sustainability Reporting (NCSR) in collaboration with the Institute of Certified Sustainability Practitioners (ICSP) to institutions that have successfully implemented sustainable performance. The assessment is based on the GRI (Global Reporting Initiative) standard by a competent assessor (Certified SR Specialist).

This award event aims to give appreciation to companies that have made sustainability reports and encourage improvements in both quantity and quality of reports, as well as increase the company's commitment to continue to contribute to the environment and society.

Finally, Soesilo added that this achievement will motivate Petrokimia Gresik to strive even better in carrying out sustainability programs.

"This is in accordance with the company's commitment to always grow with the community," he concluded.
