

**PETROKIMIA GRESIK BECOME “MOST TRUSTED COMPANY”
IN GCG IMPLEMENTATION**

[Petrokimia Gresik](#), an Agroindustrial Solutions company and member of [Pupuk Indonesia](#) holding, has been achieved the "Most Trusted Company" in the implementation of Good Corporate Governance (GCG) based on the Corporate Governance Perception Index (CGPI) in the Indonesia Trusted Companies Award national event. The award was received by the Director of Finance and General Affairs of Petrokimia Gresik, Budi Wahyu Soesilo in Jakarta, Wednesday (8/12).

There are 3 (three) categories of assessment results in the Corporate Governance Perception Index (CGPI). Namely, Most Trusted Company for a score of 85-100, Trusted Company for a score of 70-84, and Quite Trusted for a score of 55-69. The assessment in question includes aspects of self-assessment, completeness of documents, papers, and interviews/observations.

Soesilo explained that Petrokimia Gresik was achieved the "Most Trusted Company" or the highest award in this event after scoring 85.12 in the implementation of good corporate governance. This value is higher than the acquisition of Petrokimia Gresik in 2019, which was 84.70.

Previously, Petrokimia Gresik had been awarded the title of "Trusted Company" five times in the same event starting in 2012, 2015, 2017, 2018 and 2019. This year the company managed to level up to become "Most Trusted Company".

"This increase in achievement level is proof that the implementation of GCG in every business process at Petrokimia Gresik is getting better," he said.

According to him, the implementation of GCG in order to provide the best service is the foundation for the company's sustainability, especially in facing challenges. In addition, the consistent and sustainable implementation of GCG is also a form of compliance with the Regulation of the Minister of SOEs Number 01 of 2011.

Soesilo also hopes that the achievement of this award can inspire the enthusiasm of all Petrokimia Gresik people to continue to improve performance while still implementing good corporate governance in all fields.

"The consistent implementation of GCG will also support the smooth running of the company's business transformation program as an Agroindustry Solution," said Soesilo.
