Petrokimia Gresik is a company of agroindustry solution producer and the member of Pupuk Indonesia holding company achieved Company Performance Rating Assessment (PROPER) Green from Ministry of Environment and Forestry (KLHK). The award was handed over by Indonesia Minister of KLHK Siti Nurbaya Bakar to the President Director of Petrokimia Gresik, Rahmad Pribadi, Wednesday (8/1) in Jakarta.

Rahmad conveyed that this award will be a provision of Petrokimia Gresik to step forward reach the Gold PROPER. To reach Gold PROPER, a company should got Green predicate for three times in a row first.

"We commit to improve the environment management until we can reach the highest category of Gold PROPER," said Rahmad.

The Green Proper is in line with the Business Transformation Program of Petrokimia Gresik to be a company which environmentally friendly and support sustainable agriculture. It is important because Petrokimia Gresik always developing itself, until now it has a fertilizer and non-fertilizer production capacity of 8.9 million tons per year.

PROPER is a program of Company Performance Rating Assessment in environment management which was held by Ministry of Environment and Forestry. As well as the bad reputation performance in environmental management labeled RED and BLACK.

"The assessment of PROPER period 2018-2019, Petrokimia Gresik got Green predicate along with 174 companies from 2.045 companies which assessted," explain Rahmad.
