

**PETROKIMIA GRESIK KEEP
BEWARE TO FIGHT COVID-19**

Petrokimia Gresik is Agroindustry Solutions company and member of the Pupuk Indonesia holding, invites the people of East Java, especially Gresik Regency, to always comply with health protocols to prevent transmission of Covid-19.

President Director of Petrokimia Gresik, Dwi Satriyo Annurogo, stated that even though Gresik Regency currently has an orange color status or moderate risk, additional positive cases of Covid-19 are still happening every day.

"For that, it is very important for us to adhere to health protocols such as wearing masks, washing hands, and maintaining distance," said Dwi Satriyo.

Discipline to comply with health protocols, continued Dwi Satriyo, starts from the company environment. This is because Petrokimia Gresik, as a vital national object, strives optimally so that it can continue to carry out its duties to maintain national food security to the maximum amid the Covid-19 outbreak.

Regarding the implementation of internal health protocols, currently every Petrokimia Gresik Individual has an online presence. All employees are also required to conduct initial screening through examining body temperature and respiratory symptoms such as coughing, flu, shortness of breath, Medical Check Up (MCU), and rapid tests for all employees and non-organic workers who work within the company, as well as giving influenza vaccines.

"Until now, we have conducted 17,654 rapid tests, 477 swab tests, 5,426 influenza vaccines, 530 pneumonia vaccines, and have conducted 2,728 MCUs for organic employees and non-organic workers in the company environment," said Dwi Satriyo.

Furthermore Dwi Satriyo ensures that the work area at Petrokimia Gresik currently has good air circulation and has hand washing facilities, the availability of soap and water or hand sanitizers and masks, periodically disinfects all areas and around the company including the community areas around the company. .

"We also apply the Covid-19 protocol at the time of holding meetings and apply physical distancing at the reception of guests and when holding events," said Dwi Satriyo.

The company also restricts access to official housing and roads to the company; in collaboration with the police to carry out physical distancing of the main road to the company. Many employees also receive training through webinars to maintain their physical and mental health amid the pandemic.

Finally, he continued, Petrokimia Gresik implements a roadmap during the New Habit Adaptation (NHA) period that regulates working hours, company guests, official trips, internships, and a number of other activities.

"Of course, we apply sanctions for employees who do not comply with the protocol policies that have been established by the company, this is a form of the company's seriousness in supporting the government in fighting Covid-19 and maintaining national food security," said Dwi Satriyo.

Petrokimia Gresik also routinely provides drugs and supplements, foodstuffs, medical devices, facilities and infrastructure, as well as other needs to support employees in maintaining immunity and preventing Covid-19 transmission.

Armed with employee discipline, he continued, confirmation cases at Petrokimia Gresik can be minimized. For information, the construction of the Tri Dharma GOR (Rismagor) Independent Isolation Room to serve the Petrokimia Gresik Group extended family has never been used.

External Assistance

Meanwhile, Petrokimia Gresik's efforts to combat Covid-19 are not only taking place internally, but also in the community around the company so that the steps taken by Petrokimia Gresik are comprehensive.

The aid that has been distributed by Petrokimia Gresik to support the government in breaking the chain of Covid-19 transmission is provided in the form of basic necessities, medicines and supplements, food packages, medical devices, facilities and other necessities.

"Hopefully this aid will be useful and will provide a direct contribution to fighting Covid-19 in East Java, and Gresik Regency in particular," Dwi Satriyo concluded.
