

# **J. Reuben Clark Law Society Student Scholarship Application**



The October 3rd-4th Leadership Conference is an exceptional opportunity for students and attorneys to network with others in the JRCLS community, to learn about relevant legal and practical topics, and to enjoy a short time in the beautiful Rocky Mountains. To promote student attendance, registration for students is subsidized at a reduced rate. To further encourage attendance, limited travel stipends are available from the international organization. Students should also check with their local professional chapter to see if the chapter offers any student travel subsidies.

The YLSC student travel stipends will reimburse a portion of travel expenses for stipend recipients. The amount awarded to each person selected will depend on the number of applicants, the projected cost of travel, financial need, the extent of the student's involvement in JRCLS, and other factors.

## **Instructions**

**Applications will be accepted beginning July 1st and must be received no later than September 4, 2019. Funding is limited and applications will be considered on a rolling basis, so we encourage you to submit early in the process. All decisions will be communicated by September 12.**

If you are awarded a travel stipend, you are responsible for making your own travel arrangements. To be reimbursed up to the amount of your stipend, you must complete and submit an Expense Reimbursement Request (JRCLS.org, Resources/Forms/Finance). Submit the reimbursement request as soon as possible after completion of your travel. Reimbursements will be sent to you as a recipient approximately two weeks after submission. If you need the Committee to consider a variation of this reimbursement procedure, please explain your request in your personal statement.
