## Discussion:

Wylie Huffman, Indian River Lakes Conservancy, told the Board that the Preservation Alliance of Hyde Lake has recently hired the Upstate Freshwater Institute to start water sampling and testing of Hyde Lake. Mr. Huffman was at the meeting for support of the Preservation Alliance of Hyde Lake previously known as Save Hyde Lake Association. There have been a lot of algae blooms on the lake. They would like to have the support of the Town Board when they apply for grants in the future. They are asking for the community to fill out a survey in reference to Hyde Lake. Supervisor Marcinkowski said the Town will put a link on the Town's website to the survey and suggested they ask the village to put it in the village monthly light bill. Councilman Folsom stated he thought it was a back door plot by IR Lakes Conservancy to take more land off the tax roll. Supervisor Marcinkowski assure Mr. Folsom that it was only about preservation of the lake. Dale Call, Preservation Alliance of Hyde Lake, assured the Board that the survey and the reason they were at the meeting was strictly for Hyde Lake. Jean Merithew, Preservation Alliance of Hyde Lake, told the Board that they were not asking the Town for money just for their support going forward. Mr. Call stated that Hyde Lake had an algae bloom in November this year. Councilman Busler said that there was an algae bloom on Butterfield Lake in late October, which is unheard of.

Superintendent Savage showed the Board (5) quotes for mowing the ballfields and cemeteries next year. The mowing would be for (27) weeks, with the ballfields done weekly and the cemeteries done every ten days or so. \$31,000 was the highest and \$13,000 was the lowest. Supervisor Marcinkowski said that he discussed with some highway employees, and they do not understand why they would no longer be doing it. He questioned what additional work has been placed on the employees that now they can't do what they have always done. Mr. Savage

said that it takes (1) man all day to do and sometimes he must pull a man off from a job site to do it. The transfer site must try and mow the cemeteries on Wednesdays and Fridays and if it rains it puts them behind. Mr. Parmes asked if the Town could hire a part-time mower. Mr. Savage said the lowest quote is less than the men can do it for. Councilman McCarthy wondered if the Town was setting a precedent of contracting the work out. Mr. Ebbrecht stated they would be farming the work out not taking away from union employees. Mr. Savage said that the Town employees will still do the spring cleanup of ballfields and cemeteries.

Superintendent Savage discussed with the Board about going to Waste Management at the Tr. Site. It will cost the Town \$403.75 per haul from Tr. Site to Rodman. The (10) ton containers might only have to hauled bi-weekly certain parts of the year. DANC charges \$47 per ton versus the County charging \$73 per ton. The Village would still haul to the County. The Board discussed asking the Village to direct haul to Rodman to save money. A concrete base will need to be poured and electric rum for the new compactor (Waste Management provides) and the Town rents the compactor for \$360.00 per month. The Board agreed it would go with Waste Management. They thought it made more sense than to budget for a new packer which would cost approximately \$200,000.00.

- ➤ Board discussed a rent to own lease for new excavator. The payment would be \$51,000 a year. Mark thought that the Town would get \$20,000 on Town's excavator. The Board agreed to budget for it.
- The Board decided to not replace the 2008 F150
- ➤ The Board talked about leasing a skid steer at \$14,000 for (5) year lease. The Board agreed to see where the Town was financially mid-year 2022.

Discussion:

The Supervisor asked the public to leave for executive session. Judge Roberts stated she was not an employee and should be able to stay. She told the Board that as of now there was a difference in votes for Town Justice of (55). There were (33) absentee ballots out, (4) affidavits and (16) early votes to be counted. If Rebeca Oblender got all the ones to be counted, Judge Roberts stated she would still be ahead be (4) votes. She stated that it is premature to make any decision until the election is certified. She told the Board that training for a new Judge starts December 7<sup>th</sup>. Judge Roberts told the Board that she is not opposed to having (2) positions for Judge.
