Whereas, the Town Board is prepared to add a sentence to remove any ambiguity.

- 1. The Foregoing recitation is incorporated herein and made a part hereof as if set forth herein.
- 2. The Town Board hereby adds a final sentence providing "The lien shall arise and attach to the property at the time the expense and costs are necessarily incurred, and paid, by the municipality." to "Section 11. Assessment and Recovery of Costs" of the Unsafe Buildings and Structure Law.
- 3. The Supervisor for the Town of Theresa, and the Town Clerk, their respective agents and employees are herby authorized to sign all documents and take all steps necessary to enact this legislation.
- 4. The Legislation shall be filed with the New York State Department of State and shall become effective thereafter.
