Jeffrey Brunet asked the Board to name some private roads (see map of roads with suggested names) off from Burns Road. Mr. Brunet said there were (5) cottages off from the Burns Road and for emergency purposes the owners would like 911 numbers. He stated that he had gotten the blessing of the other cottage owners for the names. Supervisor Marcinkowski told him that there is a process to name the roads that will take some time. The Town Board would like to contact the owners to make sure everyone is on board with the names. Mr. Marcinkowski would like Assessor's Millett's input on the process.

Supervisor Marcinkowski asked Librarian Kristy Perry when the Library plans on using the \$15,614.00 of insurance money from the flooded roof. Mrs. Perry said that the Library Board would like it carried over to next year. She said that the Library Board has put off spending it because they have been debating whether to stay at that building, because of ADA regulations. Supervisor Marcinkowski asked Mrs. Perry who owned the books in the Library, for insurance purposes. As of now the building is insured but not the books. She said that Theresa Free Library owns the books. Tracy Hudon said that they were is the process of getting the books and historical pieces appraised.

A letter from Norseman Structures stating that the building has been installed to their specifications and that the warranty for the salt barn is in effect. The warranty has been extended for (2) years. Hybrid Building Solutions is still making some adjustments on the building.

Update of Highway Dept.:

- > Getting ready for the winter
- ➤ Back roads have all been covered
- > Turned water off at the cemetery and pulled the meter
- Allen Streeter came in (1) day last month for a burial
- ➤ Supervisor Marcinkowski asked if the men were back to (5) eight hour days yet. The contract stated that September 30th is the date to go to (5) days. Superintendent Savage said that they will go to eight hour days when Antwerp does because they are hauling sand from them. The Supervisor said that the contract should be followed on all issues or not at all.

Correspondence:

- A letter from Terry Petrie stating that there are (6) property owners on the other side of Hanson Bridge with close to one million dollars in assessments and they feel like they are ignored with the maintenance of the road and bridges. There is an erosion problem around the bridge that they would like fixed because they feel it is a dangerous situation. Superintendent Savage stated that he would take care of the issue tomorrow.
- A letter from Robert Bellinger, President/chief Electrical Inspector, requesting to perform electrical inspection for the Town, to help inspectors complete continuing education requirements. The Town Board all agreed not to do.

- ➤ Supervisor Marcinkowski will not be attending Association of Towns meeting in New York City in 2021.
- ➤ Attorney fees down budgeting less
- ➤ Historian budget will stay the same as 2020
- > Personal service for transfer site/cemetery/town buildings has been simplified
- ➤ Cemetery budget cut. April 15 used to be start date and middle of October end date. This year started middle of May and Mr. Streeter didn't work in September or October. Budget for 2021 will start middle of May and end middle of September. Budgeted 32 hours a week.
- Took a conservative approach with 2020 3rd & 4th qtr. sales tax available for budget. 2021 budget used \$80,000.00 less in case virus comes back.
- ➤ Judge Roberts has not turned in money and reports because her check book is off. Cut back 2021 revenue for justice because the Town is so far away from making budget this year in justice receipts. \$23,000 budgeted for 2020 and the Town hasn't received even \$8,000.00
- ➤ \$16,000.00 added to the budget in General and \$16,000.00 added in Highway in case of employees retiring and receiving money for sick time accrued.
- ➤ No Capital money added to the budget.
