## Discussion:

## Town Library:

Supervisor Marcinkowski told the Board that Code Officer McKeever and Superintendent Savage did a pre-insurance inspection of the Library. The Board reviewed pictures of the interior of the Library that showed it in disarray. There was a lot of trip hazards and fire issues. The water damage, that happened when the roof leaked (3) years ago, has still not been repaired. The Town received insurance money after it happened and has been carrying over each budget year. Supervisor Marcinkowski stated that the Librarian was paid all through covid with the Library closed, so he didn't understand how it look the way it does. He stated that obviously covid protocols are not being met with the amount of dust everywhere. The Board would like a letter and pictures sent to the Library Board of Trustees with a deadline to clean and make repairs.

Supervisor Marcinkowski told the Board that the contract with UniFirst for uniforms expires the end of June. He has ordered the shirts and sweatshirts for the union employees. Superintendent Savage told the Board that he thinks purchasing pants for the employees is too expensive if you go with Carhart pants and not everyone likes those type of pant. Mr. Savage stated he was just trying to save the Town money and make less paperwork. He thinks the men should be given money to buy their own style. Mr. Marcinkowski said then they would not be a uniform if not all the same and that is the point of a uniform. The Town Board all agreed to set a money amount for jeans and then use the voucher system to purchase the pants, like we do for boots.

Update of Highway Dept.:

- Next Monday the Highway will be surface treating the Baker Road & Simpson Road.
- > The fire hall/skating rink/front of Town garage will be paved soon.
- ➤ The 1986 roller broke down and cost \$3,000.00 to fix.
- ➤ The Town borrowed Alex Bay's grader for a job. Mr. Savage stated they are missing having one and he has found a used one for under \$35,000.00. He said that the Town had a pretty good winter and there would be money not spent on sand and salt (salt barn half full) to cover some of the cost. There is also \$20,000.00 in the 2021 budget for rental of equipment that could be used. The Board all agree to spend up to \$35,000.00 on the used grader from Cayuga County. Auction International can get \$2,500.00 plus on the Town's 1992 grader or the Town could scrap it.
