Returned check fee (NSF)- Raise fee?

The bank fee is \$18 for a NSF check for business accounts, we do not pay that now but there is a strong possibility that we will start to pay that fee soon if the bank policies change. Councilman Ryder asked how much work is there to send back taxes and rescind for NSF fee and how many people have returned checks? The Tax Collector stated that there is quite a bit of a process of sending back fees and paperwork to taxpayers for returned fees. It would be sufficient to raise the fee to \$30 effective immediately.

#### Update of Highway Dept.:

- Superintendent Savage went to advocacy day with Senator Walczak's office. They are aware of the Route 37 issue with speed and accidents, someone from the office will be reaching out to Superintendent Savage. Mr. Savage feels we are making headway with this issue.
- No increase for CHIPS, Mr. Savage is hopeful of an increase.
- Mr. Savage talked with Trever at Suite-Kote, hoping to be 1<sup>st</sup> on the list to get the basketball courts black topped.
- No fence for now, the poles will be cut down to even out the blacktop for the courts first.
- ➤ Mr. Savage thinks the new fence should be done in stages. Get the black top done now, then paint it and then get the lines done and that should be done professionally. (get a list of contacts together to get quotes)
