As of tonight, there will be no summer recreation. The Supervisor stated that the Town has missed the deadline to get CETA help. The Town is not sure of the guidelines that would need to be followed.

Cemetery:

- ➤ Allen Streeter is not coming back to work as cemetery laborer this year.
- (4) applicants have applied. Scott Booth & Mark Savage will interview for the position.
- ➤ Historian Timothy Minnick was instrumental in having Cozzi Monuments fix the broken stones, that were pushed over this winter, for free. Cozzi took (2) days to set the (32) stones. The Town Board would like to do something for Cozzi to show their appreciation.
- > The Town Board discussed volunteers that tried to help with the tipped stones. The Town discouraged it, since they would not be covered by insurance and it needed to be done by professionals.

The Board gave permission to the Theresa Progress Group to use the ice rink for a rummage sale from May 25 to May 31, 2021.

A letter from the Probation Department requesting the use of the court for a satellite office was read. The Board had concerns about Town Employees, availability of parking and safety. The Board agreed to discuss when COVID is over.

Mail/Correspondences:

- ❖ DEC letter about expanding the Bartlett Sand Mine requested by DBA Meeks Trucking & Plowing was discussed. The Town Board authorized Supervisor Marcinkowski to sign the request.
- ❖ Email from Mark Walczyk stating that the CHIPS, PaveNY, Extreme Winter Recovery and AIM have increased for the 2021-2022 State budget was discussed.

- ❖ A DEC letter about testing private wells near the transfer site, starting April 26th, was read.
- ❖ A letter from Attorney Burrows about cannabis legislation was read. The Town Board has the ability to opt out of permitting retail dispensaries within the Town boundaries. Councilman Folsom, Edgar, Busler and Supervisor Marcinkowski would like to opt out. Councilman McCarthy stated the use is already there and was concerned the Town could lose out on revenue. The Board will put on hold for now.
- ❖ A letter from Attorney Burrows about pending legislation about the termination of Utility service and delinquent water/sewer charges was read. The Town has (4) water customers this would affect. The Town has never had a problem with those customers having delinquent bills.

Update of Highway Dept. by Superintendent Savage:

- ➤ The CHIPS, Pave NY & Extreme Winter Recovery Program will increase this budget year by \$57.440.
- > The new radios are up and running and are working great.
- The water heater at the town barn is not working. Mr. Savage was looking to replace with an on-demand to save electricity.
- An old window in the bathroom is being replaced.
- A first inspection on the salt barn was recently done. Everything looked great.
- > The department is going to be losing an employee. Mr. Savage has started looking for a replacement.
- Raw steel prices are up so the highway is going to get rid of some surplus equipment.

Theresa Progress Group news given by Greg Parmes:

- > Food pantry is doing OK.
- Thanked the Highway for help with the topsoil at the Veteran's monument.
