Attorney letter:

Brought to the Board members' attention. Per attachment/letter from Kendall, Harrienger & Burrows to opt out of Tax Exemption for renewable energy projects. Ms. Brown states it's in lieu of tax agreements for private investors and protection from large solar farms.
