Discussion:

Lance Ronas, Daren Morgan and Trisha Amato, Indian River Ambulance Service, gave a run down of the ambulance service cost and how it operates. Mr. Ronas stated there are (4) paid employees (one full time and three part-time). There are (40) volunteers. There are always (2) people on the ambulance. Every patient gets a bill for services and they are billed off from medicare rates. They bill per mile to get to the hospital. Mr. Ronas said that they have never missed a first call, and they are very proud of that. The cost to the Town is calculated using a (3) year average. To date (August 1 to July 30) there have been 153 calls. Patients sometimes use the service several times – same person sometimes 20/30 trips. In Theresa there have been (11) drug related calls since January. They are in the process of applying for a grant for a new ambulance, which will be needed next year. They have bought (3) cardiac monitors, one for each ambulance. Mr. Ronas said that it cost \$5,000 to train an EMT, from start to finish. The Town Board appreciates everything that they do.

Theresa Town Board meeting held August 14, 2019 cont'd.

Supervisor Marcinkowski read a letter (see attached) from Attorney Burrows on Town road speed limits. The Supervisor stated that it is a very long process and he would like to take it up in the future.

Update of Highway Dept.:

- ➤ There was an accident with a Mack truck on State Route 26 driven by MEO Derrick Kolb. The truck was hauling sand and he had to swerve to miss a car coming in his lane. Mr. Kolb went to the hospital and was released with bumps and bruises. The truck has full insurance coverage and a total replacement could cost up to \$232,000.00. Supervisor Marcinkowski stated that the most important thing is that Mr. Kolb is okay,
- > Superintendent Savage is looking now for winter help. A couple of the older seasonal employees will not be coming back.
- ➤ The highway will use an old truck to plow. Superintendent Tibbles from Alexandria Bay offered the Town anything they need.

➤ Letter from JCIDA stating that their Agency would be available if the Town has any upcoming projects.

Mr. Parmes, Theresa Progress Group, told the Board that Park & Recreation helped a lot with the ice cream social. The fall festival will be September 21st. The Progress Group would like to have a horse drawn hayride at Halloween this year and would like to know if the Town could help fund.
