Discussion:

Supervisor Marcinkowski showed the Town Board a letter from Daniel Moyer stating that he had decided to not renew the Dog Control Contract with the Town. Mr. Marcinkowski said that at this point the Town is without a Dog Control Officer. Mrs. Rajner said that she has talked to a women that does Clayton and Cape Vincent and we should get a hold of her. Discussion:

A letter from Dutchess County asking for the Town to pass a "ThinkDIFFERENTLY" resolution was read by the Board. The resolution is a initiative to foster a welcoming and supportive environment for residents with special needs. Councilmember Rajner worries that the resolution could have a hidden agenda. Supervisor Marcinkowski thinks the Community already does it.

A letter from NYS DOT was read about funding for bridge programs and culvert pipes. Councilmember Rajner said that the project would have to be over \$50,000.00 to qualify. Superintendent Edgar told the Board that he needs to fix a culvert on Hyde Lake Road because the road and a driveway keep getting washed out.

The Supervisor advised the Board that he would be inviting Attorney James Burrows to next month's meeting.

Supervisor Marcinkowski told the Board that DEC has a septic replacement fund. Moon Lake and Red Lake are the lakes with the most problems. A full time resident on the lakes can get half off (up to \$10,000.00) the cost of a new septic system. Jefferson County is dealing with DEC at this time about the fund.

The Verne Sweet Scholarship Fund has a balance of \$12,651.68.

Update Highway:

*Salt barn: Matt Cooper is going to re-apply for the Salt Storage grant for next year. It will cost the Town \$200.00. The Town is going to get a letter of support from Senator Ritchie and Assemblywomen Russell.

*Mr. Edgar told the Board that (3) drivers were out with the flu. He had to bring substitute drivers and plow operators in to help out.

Mr. Parmes told the Board that March 31st the Progress Group is holding an Easter Eggtravaganza at the fire hall and ice rink.
