Discussion:

Matt Cooper told the Board that the Salt Storage Barn plans are at least a month behind due to the wet spring. He received the geo-technical report just yesterday and they are working on the design. No site survey has been done yet. Mr. Cooper said that it would be late June to put up for bid for July. The Town will need to have a special meeting to award the bid. He stated that work could then start in August and the top would be installed in October. Superintendent Savage said that he has a concern with the time frame because he needs to get trucks ready for the winter and would need to be hauling sand. Councilmember Edgar thought maybe wait until next spring to bid. The Board talked about the right to reject bids. Councilmember Busler stated that re-bids are not good. Mr. Cooper said that it is Municipal Law that the lowest bid needs to be taken.

Richard Ault asked the Board what has been done since last meeting about the Zoning Law for parking RV's for short amount time at houses? Supervisor Marcinkowski said that a list of changes to the Zoning Law has been sent on to the Planning Board for input.

Stuart Haggerty has been thinking of hosting ATV events on his 600 plus acre farm on the Holmes Road. It would be a one weekend event and would involve mud bog events. People would come and RV camp for the weekend. Mr. Haggerty stated that DEC said it was good with them and the Army Corp of Engineers just said that they would need to stay away from wetlands. Supervisor Marcinkowski said that a few things come into play, like neighbors, bathrooms and how many weekends. Councilmember Folsom likes anything that brings people into the Town. He holds boat races at Crystal Lake each fall. Mr. Ault stated that it would be a small event this year and they would see how it goes. Mr. Marcinkowski told them that he could not give an answer tonight. He would have to run by the Attorney and the Planning Board. He suggested Mr. Haggerty talk with Zoning Officer McKeever.

The Board discussed construction work to be done on the back of the Town Office that was talked about last month. The Board decided to bid the project.

He would like to pursue getting the building and using it for the Court and for senior citizen/community meeting area. Councilmember Folsom would like to see it back on the tax roll. Councilmember Edgar stated that the Town already has a lot of buildings to maintain now. The Councilmembers all stated not to pursue.

Update of Highway Dept.:

- ❖ The biggest share of paving has been done. Mr. Savage stated that hot mix is cheaper because of the thickness but cold mix holds up better. He feels if it is not broke, then don't fix it and will continue using cold mix. Also, Suit-Kote has the State contract for doing the paving. Any Company that the Town would use would have to go by the State contract.
- The price for (5) mobile radios and (3) portable radios is \$13, 859.36 from Wells Communications. The price is only good until June 30th. They are the only company that the Town can buy from. The system is not up and running as of now but the (3) year warranty for the radios will not start until is.
