### Discussion:

The Supervisor told the Board that the new Bookkeeper was a good pick and that she is very diligent. A lot of mistakes from the past have already been corrected. May & June have both been balanced. He stated that the NYS Comptroller contacted him stating that the 2020 Annual Report was not submitted. The Supervisor worked with Williamson Law Book Co. and with the Comptroller and it was filed on July 9<sup>th</sup>.

ARPA Coronavirus Local Fiscal Recovery Fund to the Town of Theresa will now be \$202,148.00. Half the money will come this summer and half summer 2022. The reason the number dropped from the \$300,000.00 that was expected is because the Fire Dept's budget had to be deducted from the total Town budget.

#### Mail/correspondences:

A letter from Attorney Burrows about the Jefferson County Industrial Development Agency rewording their policy on PILOT programs was read. One sentence in the updated policy could reduce the amount of money a Town would receive in a PILOT situation if the Town entered into additional agreements with said company. Councilman McCarthy stated that all businesses should get taxed alike. Supervisor Marcinkowski told the Board that the Town Attorney was fighting for (7) different Towns to remove the wording that affects the Town's taxes.

#### Update of Highway Dept.:

- ➤ Highway has had some breakdowns. Superintendent Savage talked about the need to update equipment.
- The Town paid \$26,000.00 for a used Grader
- Mr. Savage would like to see any extra money in the budget to go to buy trash compactor at the Transfer Site.

Use of Facilities request was granted for the Progress Group to use the ice rink for a rummage sale August 25<sup>th</sup> thru August 28<sup>th</sup>.

Jamie Papin is interested in the vacant Town Council seat. The Board would like him to be invited to the next Board meeting and could appoint at that time if he is still interested.

Judge Klepacz did not show to audit his 2020 books. A FOIL request for his petition to run for Alexandria Judge was obtained and stated on March 16, 2020 he signed a witness statement that he resided at 25230 NYS Route 26, Redwood, NY. There is a residency requirement for elected officials to live in the Town they are elected. The Board worried about technicalities arising if he proceeds over any court duties. The Board wants his pay to be stopped and for Mr. Klepacz to turn in his key to the office. The Board would like a letter from the Town Attorney addressing this issue.
