While we treat submissions confidentially to the extent allowed by law, we cannot guarantee complete anonymity.

We encourage prompt reporting of incidents stemming from fear, misunderstanding, hatred, or bias to help us gather information effectively. Share all of the information you know, a delay in submission of this form may hinder the ability for the University to respond.

This form should be used to review:

- Incidents of bias connected to protected class and identity.
- Incidents that negatively impact the campus climate focus on creating a welcoming environment for all.
- A conflict that has negatively impacted connections at the University.

Definition of Roles:

- **Targeted Person:** The person on the receiving end of the alleged incident.
- **Responding Party:** The person who initiated the alleged incident.
- **Witness:** The person who was present and saw the incident.
