LIST OF PROHIBITED PRODUCTS

I. PROHIBITED PRODUCTS THE CANNOT BE SOLD (PURSUANT TO THE LAW OR PLATFORM RULES)

- firearms, components of firearms, ammunition, explosives, airsoft type weapons and ammunition;
- dangerous materials and tools: explosive materials, explosives, flammable materials, materials with toxic or caustic effects, radioactive materials, infectious materials or at risk of infection, solutions dangerous to humans, respectively any other materials, which may have adverse effects, due to the characteristics his, on man;
- drugs, precursors, toxic chemical inhalants, as defined in the legislation in force;
- dangerous products according to ADR (explosive, infectious substances, organic peroxides, corrosive materials, etc.);
- food and beverages not properly packaged;
- sanitary samples (including body fluids and tissue samples);
- human remains and ashes, parts of the human body, human tissues or organs;
- means of payment that replace cash: for example, bank card, debit card, meal vouchers, holiday vouchers, securities, cryptocurrencies;
- banknotes; coins;
- gas (e.g. gas spray);
- hunted trophies (animals), parts of animals such as ivory, shark teeth, animal remains or products of animal origin and derived products that are not for human consumption, prohibited in circulation by CITES, other international conventions or local law;
- tax stamps;
- medicines that are marketed with a medical prescription;
- products containing violent or offensive material that has no historical significance;
- products that promote, incite or glorify hatred, violence, discrimination, harassment, acts of war, sexual violence against any person, categories of persons or groups and that have no historical significance;
- products that promote or glorify suicide, pornography;
- products related to terrorist organizations, money laundering schemes or criminal activities, products for which there are marketing restrictions established at local, European or international level;
- products that promote or glorify people who have been found guilty of violent, sexual or other types of crimes and that have no historical significance;
- fascist, legionary, racist or xenophobic symbols, other than those that are part of or are included in products with historical significance;
- live or dead animals or birds;

- flammable materials (for example: petrol, diesel, fuel oil, liquefied gas);
- products from the gambling and lottery category;
- shares/parts held in companies, blocks of shares/parts, bonds and other securities, debts, units of investment funds, policies and insurance products;
- expired products, products whose marketing authorization / marketing license has been withdrawn or has not been obtained, according to legal requirements;
- OTC medicines (without medical prescription) or prescription drug The nomenclature of medicines for human use can be consulted at: https://nomenclator.anm.ro/medicamente;
- pyrotechnic items from categories P1; T1 and from categories F2/F3/F4/T2/P2 that can only be sold to professionals;
- temperature-sensitive products, the transport of which requires cooling or heating; (e.g. food, perishable products);
- veterinary medicinal products without medical prescription;
- jamming devices (jammers; signal isolators) that prevent the normal functioning of GSM, GPS signals etc.;
- products containing Hexahidrocannabinol (HHC) (e.g. oil, food supplements, cosmetics etc);
- products containing TetraHydroCannabinol / Cannabidiol (e.g. oil, food supplements, cosmetics, etc);
- food products containing CBD;
- products containing TetraHydroCannabinol (THC) and derivates (e.g. hemp seeds; ground hemp seeds, (partially) defatted hemp seeds and products processed exclusively from hemp seeds, such as flour, protein bars, teas; hemp seed oil);
- customized products according to the consumer's specifications (products for which the client's intervention is required);
- plant protection products (e.g. pesticides such as acaricides, bactericides, fungicides, herbicides, insecticides, molluscicides, rodenticides etc);
- tobacco for oral use (tobacco packets "snus");
- gold, gold coins, diamonds, steel, aluminum or copper products originating in restricted countries or territories, as well as any other products restricted to import, trade or export, according to the legislation in the field of international sanctions;
- products containing food additives prohibited by the legislation in force (e.g. titanium dioxide E171);
- disposable plastic products;
- flail-type cutting attachments for portable hand-held brush cutters;
- car seats with ECE R44 certification;
- mercury thermometers;

II. PRODUCTS FOR WHICH IT IS NECESSARY TO INSERT DOCUMENTATION IN THE IMAGE GALLERY

- medical devices (e.g. medical masks, pulse oximeters, covid tests);
- Individual Protection equipment (e.g. protective masks FFP1/2/3);
- products that interfere electromagnetically; (UVC lamps and other devices that have an integrated UVC lamp (e.g. phone sterilizer, key sterilization box, etc.).

not contain a clear description of the marketed product. (to include information

well as any other essential information for the consumer in making the purchase
decision).

VI. PRODUCTS WITH A SPECIFIC CHARACTER

- movable cultural goods and icons, without obtaining the necessary authorizations or sold in violation of its provisions, as the case may be;
- consumables for cash registers (e.g. thermal paper rolls, data cable, charger).
