- Scenario 4 pertains to individuals with both illegible handwriting and signature. They may not even present an appealing facade, instead embodying a deep-seated disdain for societal norms. Such individuals pose a significant risk of engaging in deceitful and harmful behaviours.

These scenarios underscore the psychological insights that signature analysis can offer. By examining the legibility of a person's signature in relation to their handwriting, we can infer the congruence or disparity between their private selves and the image they project to the world.

It reminds us that while signatures may be the masks we choose to wear, our handwriting offers a glimpse into the soul beneath, revealing the truth of who we are.
