## USE OF TOWN PARK PAVILION AND PROPERTY AGREEMENT

User agrees to further indemnify and hold harmless the Town of Sunderland and its servants, agents, and employees from any and all claims and the cost of defending them, actions, causes of action, injuries, damages, judgments, and any and all other claims or damages of whatever type or nature which may hereafter at any time be instituted, claimed or recovered against the Town of Sunderland which may arise out of or in conjunction with the use and custody of said area by user.

- 1/2 DAY (4 hours max.) USER FEE \$150; plus \$100 SECURITY DEPOSIT (separate checks)
- 1 FULL DAY (calendar day only) USER FEE \$300; plus \$100 SECURITY DEPOSIT (separate checks)
- 2 FULL DAYS (2 calendar days with night in-between only): USER FEE \$500; plus \$100 SECURITY DEPOSIT PER DAY (i.e.: 2-day rental is a \$200 security deposit)(separate checks)
- UTILITY FEE \$50 per rental day; Check made payable to: Town of Sunderland. (ie.: 2 day rental = \$100 Utility fee)
- Special Liquor License Request** - Separate One-Day Alcohol License application and applicable fee must be completed and presented to the Board of Selectmen no later than fourteen (14) days *BEFORE* event. Applicant must submit Certificate of Liquor Liability Insurance to the Board of Selectmen *BEFORE* event. See One-Day Alcohol License application for terms and agreement.
