LiFi (Light Fidelity)

- Is an emerging dual use technology for data transfer at fast data speeds that uses optical transmissions
- Has a lot of capabilities where WiFi is limited due to WiFi's use of the radio frequencies
- Can be used to complement or Replace WiFi
- Has an extremely open market even though it has distance transfer limitations
- Changes the Landscape for the Internet of Things
- Provides Stealth capabilities

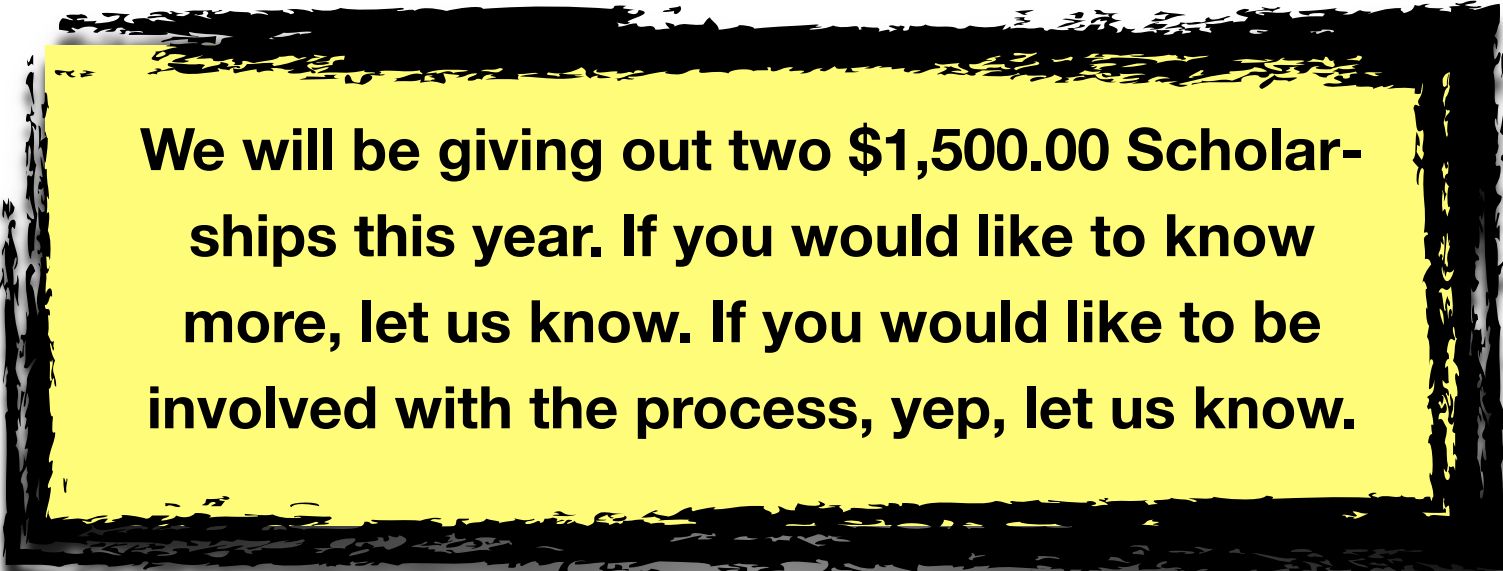

- [FAR Clause 52.204-21 Basic Safeguarding of Covered Contractor Information Systems](#). Effective June 15, 2016, all contracts awarded by any U.S. federal agency, including DoD, must include Federal Acquisition Regulation (FAR) Clause 52.204-21, which requires immediate implementation of 15 controls, which equate to 17 NIST SP 800-171 controls for basic safeguarding of any internal systems with non-public "federal contract information" or FCI. Patriot Act, Computer Fraud and Abuse Act and the Digital Millennium Copyright Act

ISSC 343 Wireless Networking I have taught wireless networking for the past year which covers in-depth study of protocols, transmission methods, and IEEE 802.11 standards. Students are required to develop wireless presentations to fictional clients resolving network problems with LANs, WANs, MAN, using WIFI, Blue Tooth, and other Rf solutions. This course offers discussion in state of the art wireless transmissions including LiFi, SDN, NFV and other innovative networking techniques for the IoT.

ISSC 361 Information Assurance I have taught the Risk Mitigation course and covered all aspects of Information Security and lessening the risk to organizations from outside threats. Develop mitigation plans, implement IT defensive tools, perform cost analysis and threat analysis.
