This Oracle Advanced Collections is a separate module that sits on-top of Oracle Accounts Receivables providing users a very wide range of collections activities and functionalities and thereby taking collections to a next level.

Oracle Advanced Collections uses many business essential features like notes, territory management, resource management etc., from Oracle CRM. And it integrates well with Oracle Credit Management Module.

Here are some best features of Oracle Advanced Collections in different areas of receivables management.

Collections:

- 1. Providing an every day work queue of customers at different levels (bill-to, customer, account & delinquent levels) for collectors
- 2. Providing a strategy to collect on customers (different strategies can be assigned to different collectors



Upgrading Oracle applications to R12

Introduction

Upgrading Oracle applications to a new release such as R12 in a very complex environment can be challenging. This presentation focuses on the reasons for upgrading to R12, technology stack components in R12, upgrade path from various old releases of Oracle applications, pre-upgrade steps, upgrade steps, post-upgrade steps, and tips to minimize the downtime to make the upgrade a success. This paper is also an attempt to compile and consolidate various activities required during the upgrade from several metalink notes and upgrade document. More emphasis has been given on the technical tasks during the upgrade. The functional tasks will require engaging subject matter experts during the upgrade process to complete necessary tasks based on the client specific TUMS and maintenance wizard report. The tasks listed in the document can easily be converted to a project plan. All clients, consultants, DBAs, architects, project managers planning their oracle applications upgrade to R12 will significantly benefit from the details discussed in this paper.



- 10.gAS 10.1.3 is used for Oracle Application Framework and all java based applications that 9iAS 1.0.2.2 provided in 8.1.7 Oracle Home
- Integration with external systems is accomplished through 10gAS 10.1.2 for integration services, identity management, portal, discoverer, and web cache

- Applications R11.5.6 and below requires to first upgrade to R11.5.10.2/10gR2
- Applications R11.5.7 and up can be directly upgraded to R12
- Database in all releases must have been upgraded to 10gR2 (11.5.9.2 / 11.5.10.2) or should be done during upgrade to R12 (11.5.9.1/11.5.10.1 and below



Pre Upgrade Tasks

1. Apply 11i.AD.I (conditional)

It is Mandatory to have 11i.AD.I minipack on all application tier nodes. Refer to note# 233044.1 for more details

- 2. Run TUMS utility
 - Apply patch# 5120936 to the administration server in 11i Environment
 - cd \$AD_TOP/patch/115/sql; sqlplus <APPS username>/<APPS password> @adtums.sql <DIRECTORY>
 - tumsr12.htm report lists the steps that can be safely ignored.
- 3. Back up database, Applications, and customizations (recommended)
- 4. Prepare an upgrade plan for customizations (conditional)
- 5. Convert to Multiple Organizations architecture (required).
 - Follow metalink note#210193.1 for more details.
- 6. Drop event alert triggers in custom schemas (conditional)
 - cd \$ALR_TOP/patch/115/sql.
 - Sqlplus apps/apps @alrdtrig.sql
 - Re-create the triggers after the upgrade
- 7. Review sizes of old and new tablespaces (required)
 - Add 20% additional space to all tablespaces.
 - Use note# 399362.1 for more detail.
- 8. Run AD preparation scripts (required)
 - Apply patch# 5726010 to pprepare the system for conversion to OATM
 - Run adgncons.sql to configure the database to hold the new products to be added during the upgrade, and switche the system to use the new tablespace model.
 - Run adcrtbsp.sql to create the new tablespaces, allocate unlimited tablespace to all APPS users, update fnd_product_installation table with correct data and index tablespace information, assign default tablespace to all APPS users, and sets the new_ts_mode flag in fnd_product_groups to Y.
 - Run adgrants.sql to grant SYS privileges needed by Applications, and create required views in SYS.
- 9. Convert Oracle Alert E-mail Processing to the Workflow Notification Mailer (conditional)

If response processing alerts is used then apply 11i.ATG_PF.H Rollup 4 (patch 4676589) to convert Oracle Alert to the Workflow Notification Mailer.

- 10. Conditionally complete product specific pre-upgrade tasks
 - Customer Relationship Management Tasks
 - Financials and Procurement Tasks
 - Projects Tasks
 - Public Sector/University Tasks
 - Supply Chain Management Tasks
- 11. Gather schema statistics for CBO (required)
- 12. Back up the database (recommended)
- 13. Run Rapid Install (required)

- Use Rapid Install wizard to lay down the file system and install the new technology stack for R12.
- Start Rapid Install/rapidwiz
- Select Upgrade to Oracle Applications Release 12.
- Select Upgrade Action screen,
- Select Create Upgrade File System.
- Enter the parameters required to set up your new environment.
- Run Rapid Install.
- Rapid Install delivers the unified upgrade driver that is used later to perform the upgrade. It is also run again after the upgrade to configure and start the servers and services.
- 14. Migrate or upgrade the database to Oracle 10g Release 2 (conditional)

It should be noted that Oracle applications R11.5.9.2 and 11.5.10.2 are certified with 10gR2. If the current application is running on R11.5.9.2 or R11.5.10.2 taking this step will reduce the downtime during the upgrade. If already not on 10gR2 use the instructions in metalink note# 403339.1 to upgrade the database to 10gR2.

15. Conditionally review pre-upgrade patches listed in Appendix - 'A"

Upgrade tasks

Enable PDF printing (required)

The PDF Publisher print style and PASTA_PDF printer driver provide the capability to print PDF files using a third-party utility.

The -Pasta Universal Printer type has been associated with the style and driver for ease of use

- Specify a temporary directory for XML Publisher (required)
- 12. Verify completion of concurrent programs (recommended)
 - The upgrade process creates numerous concurrent program requests.
 - These jobs are automatically started once apps services are started
 - The complete data cleanup and upgrades to historical data.
 - These programs run in the background, while the system is up and running and users are active,
 - Be sure all the concurrent programs generated by the upgrade have run successfully
 - Refer to note# 399362.1 for more detail.
 - Make use of the best practices to isolate concurrent manager queue for the post upgrade tasks
- 13. Install online help (recommended)
 - Adpatch u5051400.drv located in \$AU_TOP/patch/115/driver directory with options=hotpatch,nocopyportion,nogenerateportion.
 - Repeat the above for each active language.
- 14. Update/verify custom responsibilities (conditional)
 - System Administrator responsibility, navigate to Security > Responsibilities. Query each custom responsibility and update as necessary.
- 15. Migrate custom development to new technologies (recommended)
 - Mod_plsql to Oracle application Framework
 - Reports to XML Publisher
 - Forms and charts to Framework based application
 - Personalizations in the same db are preserved
 - Copy and re-customize modified scripts or reports (conditional)

What you can do now?

Even if you don't have a plan to upgrade to R12, please do clone your production instance and plan an upgrade to know all the steps required for your instance and get a clear picture of issues, fixes, downtime, etc. It is mandatory to be on 10gR2 for upgrade to R12. Plan your application/database upgrade in advance to minimize the down time during final upgrade.

How to be successful

Successful upgrade requires lots of planning and testing. Following tasks should be planned and executed carefully to make the upgrade a success:

- 1. Early planning
- 2. Develop upgrade Strategy
- 3. Plan upgrade path
- 4. Ensure adequate hardware resources
- 5. Ensure skilled staffing resources
- 6. Easy access to training and documentation
- 7. Study technical impacts
- 8. Study functional impact carefully
- 9. Testing of key features
- 10. Multiple test upgrades
- 11. Cutover and transition tests
- 12. Identify upgrade downtime target
- 13. Downtime reduction versus ease of upgrade

Recommendation

Use of Maintenance Wizard is recommended to guide through the upgrade process. It draws on instructions from numerous manuals and other documentation to provides a complete picture of the activities required for an upgrade. The Maintenance Wizard helps in reducing upgrade tasks by dynamically filtering the necessary steps based on criteria it obtains from applications environment. The resulting report is a set of step-by-step instructions that needs to be followed to complete the upgrade. It can also automatically execute many of the tasks reducing the possibility of errors or accidental omission of any tasks.
