#### 4) Chair's Report

Welcome to our latest Coventry Rugby Supporters Club AGM.

I welcome new members, old members and ask you, if you enjoy or appreciate what we do, then tell a friend and get others to join. This club is run purely by Coventry Rugby Supporters on a voluntary basis. If we can help, we will.

Where do I start? Almost 18 months of anxiety, apprehension, knock backs and desperate times for us, some more than others. To anyone who has suffered loss during the pandemic, you have my sincerest sympathies and respect. I hope you have found a better place.

Last season, the ten game dash, mostly played under spectator free conditions was a very strange, but curiously positive one for me. As expected, Saracens overcame Ealing Trailfinders to return to the Premiership. I thought Saracens treated the Championship with respect, I wish I could say the same for some of our supporters when they visited in May, a few people forgot rugby traditions. I was quietly pleased with Cov's performances during the shortened season, could see a positive and vibrant team, lots of effort which culminated in our only away trip, and win, at Richmond. It felt good, despite the restrictions and protocols, to travel. I look forward to more away days.

In June the RFU Council rubber-stamped the proposal on the relegation moratorium, to be expected, when members probably had their 'perks' threatened, lunches at HQ, International tickets etcetera. Too much like lemmings or turkeys voting for Christmas. I suspect when the full story of the voting intentions of Championship clubs are ever revealed, it could form the basis of a decent whodunnit.

I hope all Coventry Rugby supporters will consider if the Guild is for them or not, but the more involvement, the higher chance of success. I think to paraphrase John F Kennedy, it would be best to:

CRSC Membership for 21-22 will remain at £20 and all members who paid up for season 20-21 will be offered free membership if they so desire

## 6) Academy Sponsorship (u18s - u23s)

- For the past 2 seasons the Supporters' Club have proudly sponsored the u18s at a cost of £5,000. The proposal being put forward by the Committee to the members was to consider extending this sponsorship to cover the entire Coventry Rugby Academy (u18s u23s).
- It was agreed by those in attendance that the Supporters' Club should adopt the proposal to extend its sponsorship to cover the entire academy as the members felt the investment would be beneficial in the longer term for both supporters & Coventry Rugby Club.

## 7) Coventry Rugby Supporters' Guild

- A small working party comprising representatives from Coventry Rugby & the Supporters' Club
  has been formed to evaluate how supporters could potentially own a stake in the rugby club,
  through the acquisition of shares. The working party meets several times throughout the year
  and has branded the proposal, 'Coventry Rugby Supporters' Guild', of which the salient details
  developed by the working party to date are as follows, however, a significant amount of works
  remains to bring the proposal to fruition:-
- Coventry Rugby Supporters' Guild is to be an independent, democratic, not-for-profit, community-based organisation. It will be regulated by the Financial Conduct Authority (FCA) and it seeks to give supporters a collective voice and a stake holding in the running and ownership of Coventry Rugby Limited. This stake holding will be achieved via a membership subscription to the Guild, which will then be used to purchase shares in Coventry Rugby.

- It should be noted that the Guild will be a separate legal entity in its own right & independent of Coventry Rugby Limited. It will be governed by its own elected Board in accordance with a defined Constitution.
- The objective of the Guild will be to raise funding for capital investment projects to support Coventry Rugby's investment in infrastructure, to improve supporters' match day experience, support the club in driving revenues and giving supporters a voice at the heart of Coventry Rugby Club.
- The Guild will not fund any operating expenditure incurred by Coventry Rugby.
- The Guild will be a shareholder in Coventry Rugby Limited & have a position on the Board.
- The team behind the Guild are a group of long-term supporters with a range of skills & experience. They are working purely on a voluntary basis without remuneration, receiving advice & assistance from the relevant regulatory bodies to ensure legislative & financial compliance.

## 10) Special Resolution - Honorary President

- Guidelines as to how Honorary Memberships could be awarded were presented and formally agreed at the very first Supporters' Club AGM (14<sup>th</sup> September 2017).
- The guidelines agreed and accepted for Honorary Membership are:
  - > The subject enjoys popularity
  - > The subject endorses the organisation
  - > Gives the organisation respectability / credibility
  - Adds value to the organisation just by associating their name with it
  - > Enjoys a certain respect among the membership
  - > The subject is "allowed to be part of a club without ever having actually formally completed the membership requirements and therefore has no voting rights"

- > An accolade bestowed in recognition by the membership
- > The subject would be well respected and honoured as a figurehead
- In view of the criteria above it was proposed and unanimously accepted by those attending the AGM, that Jon Sharp (Executive Chairman of Coventry Rugby) should be awarded the accolade of 'Honorary President of Coventry Rugby Supporters' Club'.
