

STUDENTS FOR LIFE AT UCSD CONSTITUTION

ARTICLE I. NAME OF STUDENT ORGANIZATION

The organization shall be called "Students for Life at UCSD".

ARTICLE II. STATEMENT OF PURPOSE

There are a few purposes for the creation of this organization. One purpose is to offer a designated time and place (through weekly meetings the club will hold) for civic dialogue concerning the topic of unborn life and the reasons to protect it. Many students are unaware, misinformed, or ignorant on the topic of unborn life in general; therefore, another purpose for this club is to offer information to UCSD students with regard to the moral and political implications that come when unborn life is neglected and disrespected. Furthermore, political legislation made with respect to unborn life will be presented at weekly meetings to show members how politicians are making decisions in law based on the topic of unborn life.

Students who wish to participate in this dialogue are encouraged to contribute to the conversations that occur during the weekly meetings regardless of viewpoints so long as their arguments are put forth in a professional, respectful, and calm manner.

The principal members understand that the discussion of this topic may be charged with emotions. The principal members hope that participants will have an opportunity to exercise self control over their emotions and maintain a level headed, rational attitude when it comes to contributing in the group meetings. There will be no tolerance for abusive, hurtful, unkind, or disrespectful language. Any participant who behaves in this manner will be asked to leave the meeting. Should a participant refuse to listen to the principal member, the principal member has the authority to end the meeting early and/or call campus police if they perceive the situation requires such attention.

ARTICLE III. NONPROFIT STATEMENT

Students for Life at UCSD is a non-profit student organization.

ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP 1.

Any registered UCSD undergraduate student may become an active member by regularly attending meetings and submitting their student PID, email, name, and last name.

ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

The organization shall have regular meetings once a week on Wednesday from 2:30 to 3:30 PM. The meetings will be held on UCSD's campus with specific information on location sent out

to members the Monday of that same week. Meetings will be guided by at least one principal member. The officers will call for any other meetings as necessary and alert members for the new meetings.

ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS 1.

Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers. There will be a max of three officers running the Students for Life Club at UCSD. This number may be increased at the discretion of the principal members but not decreased. The principal members will be decided on the Sunday after finals week of the spring quarter each year. The members will maintain office for a period of 1 year until they must decide again to continue serving as officer or submitting the role to another member. If an officer should no longer have the time or desire to contribute to the club, they may leave their position allowing the other officers to select a replacement person to fill in their role.

ARTICLE VII. RISK MANAGEMENT 1.
