#### 4CORNERS CHRISTIAN FELLOWSHIP AT UCSD CONSTITUTION

## ARTICLE I. NAME OF STUDENT ORGANIZATION

The organization shall be called 4Corners Christian Fellowship at UCSD.

### ARTICLE II. STATEMENT OF PURPOSE

The purpose of this organization is to provide all undergraduate students, but in particular international undergraduate students, the opportunity to learn about Christianity through studying the Bible and participating in Christian fellowship.

## ARTICLE III. NONPROFIT STATEMENT

4Corners Christian Fellowship at UCSD is a non-profit student organization.

## ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

- 1. Any registered UCSD undergraduate student may become an active member by regularly attending meetings and paying membership dues as they become due, the amount of which shall be established from time to time by the officers.
- 2. Membership may be cancelled: i) upon the member's request; ii) if the member is continually absent for a quarter to regular meetings; iii) if the member fails to pay membership dues; or iv) by vote of the officers if the member is found to be involved in misconduct.

# ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

The organization shall have regular meetings once a week. The officers will call for any other meetings as necessary.

# ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

- 1. Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers.
- 2. The officers of this organization shall be President, Vice-President, Secretary, and Treasurer. Any other post may be established by the decision of the officers.
- 3. The duration of the officers' terms shall be one full year, or until new officers are elected. In the event of resignation or termination of officers, new officers shall be appointed by the remaining officers.

- 4. The election of new officers shall happen during the Spring Quarter. The current officers shall nominate a panel of new officers, and election shall be for the entire panel of new officers. The new officers shall assume their positions in the Fall Quarter following their election.
- 5. The officers shall have been members for at least 2 full years as of the beginning of their term (upon establishment of a member roll).

### ARTICLE VII. RISK MANAGEMENT

- 1. 4Corners Christian Fellowship at UCSD is a registered student organization at University of California, San Diego, but not part of the University itself.
- 2. 4Corners Christian Fellowship at UCSD understands that the University does not assume legal liability for the actions of the organizations.

## ARTICLE VIII. COMMUNITY ADVISOR

The officers shall select the community advisor(s) to advise the organization during the term of the officers.

# **ARTICLE XI. AMENDMENTS**

Any amendment to this Constitution will be affected by a 3/4 majority vote of the officers of the organization, and shall be filed with the UCSD Center for Student Involvement.

# ARTICLE X. DISSOLUTION

If this organization is dissolved, all unspent funds will be allocated to other student organizations or other nonprofit organizations.
