UC San Diego American Mock World Health Organization (AMWHO) Constitution

Article I. Name of Student Organization

The organization shall be called American Mock World Health Organization at UCSD.

Article II. Statement of Purpose

The American Mock World Health Organization of UCSD looks to provide a setting to students that offers new material and opportunities to expand the level of critical thinking as related to world health. Promotion of learning in the context of foreign affairs through W.H.O mock conferences will provide students the opportunity of participating in political diplomacy settings. Self development and comprehensive thinking will be a mission of the American Mock World Health Organization of UCSD. Further expanding knowledge and experience of such. Local and national conferences will be offered to those reaching the necessary organization requirements.

Article III. Nonprofit Statement

The American Mock World Health Organization at UCSD is a non-profit student organization.

Article IV. Requirements for Membership

UCSD undergraduate who are interested or concern in world affairs will be eligible for membership of the American Mock World Health Organization. There is no fee charged for membership. All the members will get involved in each event and each meeting, so it is easily identified.

Article V. Frequency of Organization Meetings

Meetings will be held bi-weekly or as needed. The set amount of required meetings will depend on the quarter and events occurring during that time. Minutes will be taken and provided to the general body to inform members that could not attend the meeting.

Article VI. Qualifications for Holding Office and Methods of Selecting and Replacing Officers

Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers. There are two co-directors and 5 other officer positions. Each position will be in charged of different aspects of the organization. Only registered UCSD students

are eligible for the principal members positions. Elections will be held in the end of spring quarter once a year for officer positions, once elected they will immediately serve as their set position.

Article VII. Risk Management

American Mock World Health Organization at UCSD understands that the University does not assume legal liability for the actions of the organization. Name of Org at UCSD is a registered student organization at the University of California, San Diego, but not part of the University itself.

Article VII. Section 1. In Case of Interaction with Minors and/or the Elderly

American Mock World Health Organization at UCSD is aware that all registered student organizations that serve minors or the elderly have access to training on child and elder abuse prevention for its members via the Center for Student Involvement, online or in person (in person by request only). American Mock World Health Organization will develop plan(s) for activities and events where members will be interacting with minors or the elderly such that members will receive education and/or training on Child Abuse Neglect Reporting Act (CANRA), common sense measures to both avoid child or elder abuse allegations (i.e. avoiding one-on-one situations; working with minors in plain view of others; limiting calls/texts/social media posts or other communications with minors), and how to properly report potential harm or neglect to minors or the elderly with whom they are working.

Article VII. Financial Management

Fundraising through means such as selling various foods on library walk will be used to finance events and activities that require money for travel and other expenses. This will be handled by a designated officer of finance. This person will submit budgets to the A.S when appropriate.
