TUITION

Grades K – 8 \$4,200

Discount of 5% for BSSDA Church Constituent. Discounts also given for additional children at the following rates: 1st Additional Child 10%, +5% each additional child in increments.

FEES

(due preferably at registration but by start of school)

Annual Registration Fee (books/testing/etc.- non-refundable).....\$280

TRANSPORTATION

(due preferably at registration but by start of school)

.....\$525

Transportation is provided from the City of Buffalo on a first come first served basis and contingent on availability. You must be fully registered with account current to reserve a seat on the van. If requesting 2 installments, payment of \$275 by start of school, another payment of \$275 due prior to Christmas Holidays break. Late payment incurs a 5% fee.

TUITION PAYMENT SCHEDULE

Tuition may be paid in ten (10) equal payments. First payment is due by 1st day of school, subsequent (9) payments are due by the 15th of each month (Sept. through May).

If due date is on a weekend or during a break, then payment is required the school day before the weekend or break.

** If tuition payment is received by DUE DATE a 2% Discount may be applied. **

** For Payment in Full prior to start of school year a 5% Discount may be applied. **

Payment not received by the last day of the month will incur a 5% late fee.
