

Email Sent to Bruno Devita (insurance lawyer), Marlena McMurtry (Gov. Lawyer), Jinnifer Tims (Crawford and Co. Manager), Claudia (Supreme Court Scheduling Victoria)

Glorious Day to you all,

It's been almost 2 years since we were last in contact about the sexual exploitation of children by government funded employees in Diving Plongeon Canada.

Due to almost all members working in the Justice industry on this case (Victoria Case #202598) suppressing the record, the exposure of the crimes that have been going on in Diving Canada never came to light...putting me through further malady and continuing to put the children of our country at risk.
