#### WNA General Meeting Review: May 11, 2006

The Woodmere Neighborhood Association met on Thursday, May 11, 2006 for its quarterly meeting. President Sam Whatley called the meeting to order with about 55 people present. Guest speakers were Councilman Charles Jinright, Molly Stone, Judge Reese McKinney, Trey Granger and Sonya Henson. . Councilman Jinright gave attendees an update on the city and how well Montgomery is doing. He commended the Association for being one of the better neighborhood associations in town.

Molly Stone, Museum of Fine Arts Development Officer, gave an update on the new edition of the Museum. With the new edition, there is a new Exhibition Gallery as well as a new Children's Gallery.

Judge Reese McKinney, Trey Granger and Sonya Henson of the Probate Judge's Office explained the new voting system that is being used this year. The new method was demonstrated and a number of those present participated in the demonstration.

President Whatley shared some crime statistics for our area based on information that was received from the MPD.

The reconfiguration of the zones was discussed as well as the need for Zone Coordinators and Block Captains. New zone maps are available.

A fall event is being planned for the park to include a cookout.

The Streets and Sidewalks committee continues to observe problems. Cars are being reported to the police department for parking at the park after dark.

All members were reminded that dues expire on December 31 of the year in which they are paid.

The By-Laws are being revised and will be available on the website. The changes will be presented at the August meeting. A vote will be taken to amend the By-Laws at the November meeting.

There was no other business and the meeting was adjourned. The next meeting will be Thursday, August 10 at 6:30 p.m. in the Museum of Fine Arts. Members and nonmembers are encouraged to attend.

The Freecycle Network™ is made up of many individual groups across the globe. It's a grassroots and entirely nonprofit movement of people who are giving (& getting) stuff for free in their own towns. Each local group is moderated by a local volunteer. Membership is free.

The Freecycle Network was started in May 2003 to promote waste reduction in Tucson's downtown and help save desert landscape from being taken over by landfills. The Network provides individuals and non-profits an electronic forum to "recycle" unwanted items. One person's trash can truly be another's treasure!

How does it work? When you want to find a new home for something – whether it's a chair, a fax machine, piano, or an old door – you simply send an e-mail offering it to members of the local Freecycle group. Or, maybe you're looking to acquire something yourself. Simply respond to a member's offer, and you just might get it. After that, it's up to the giver to decide who receives the gift and to set up a pickup time for passing on the treasure.

Our main rule: Everything posted must be free, legal, and appropriate for all ages.







#### **How Much Does A Neighbor Cost?**

A good neighborhood takes good neighbors. But to have such a neighbor, you need to be one. Ever wondered how your yard, vehicle, or pet might be affecting your next-door neighbor? Reflect on this story reported recently from the African nation of Benin.

It seems a golfer went to the manicured grounds near the Benin airport to hit a few golf balls. He sliced one high and wide. It struck and killed a bird that fell into the windshield of a fighter jet. The pilot trainee who was taxiing the plane lost control, careening his aircraft into four other jets on the tarmac. All five aircraft, comprising the entire Benin Air Force, were totaled. Damages amounted to \$40 million. The golfer was charged in court with hooliganism and ordered to repay the government. But the judge soon discovered that, with the man's \$273 per year salary, it would take him 146,520 years to pay it off, if no one added any interest.

Even if you are not a golfer, there is a lesson here. Take care in dealing with your neighbors. A little carelessness could snowball into a major problem. But a kind word or action can prevent a mountain of discord. And remember, a neighbor is a potential friend who lives nearby.
