The following is directly from the City of Montgomery's Code of Ordinances and is posted here as a friendly reminder.

Chapter 23 - SEWERS AND SEWAGE DIS-POSAL

#### ARTICLE II. - STORM SEWERS AND DRAIN-AGE

Sec. 23-32. - Obstruction of flow in sewers and ditches.

It shall be unlawful for any person to obstruct or interfere with the natural flow of water through any drainage ditch or sewer in the city. (Code 1980, § 40-28)

The Calabee Creek battle resulted in only 50 Red Sticks killed with about 25 of the Georgians and friendly Creeks killed plus at least 150 wounded. Floyd's army remained in this camp for a week while nursing their wounded. During this time, they were continuously harassed by small attacks by the Red Sticks. Unsure if another large scale attack might be coming, Floyd determined to move back to Ft. Hull and later to Ft. Mitchell. Floyd was sure that Ft. Mitchell would be attacked in due time. The column was repeatedly harassed by Red Sticks along the line of march. After the Georgians finally reached the relative safety of Ft. Mitchell, many of the Georgia militia's terms of enlistment were ending and the men were discharged and sent home. After this time, the Georgia militia and General Floyd would no longer play a role in the First Creek

This will conclude our time with Chasing Our Tales for this visit. We will lay the ground works for the conclusion of the First Creek War in our next visit which will be our 20<sup>th</sup> encounter with Chasing Our

# **Open Burning**

The following is directly from the City of Montgomery's Code of Ordinances and is posted here as a friendly reminder.

#### **Chapter 13 - FIRE PREVENTION**

### Sec. 13-9. - Open burning.

- ((b) Open burning unlawful. It shall be and is hereby declared unlawful for any person to kindle, start, maintain. or otherwise produce or propagate any open fire at any location within the city limits without first obtaining a burn permit issued by the city fire department. It shall further be and is hereby declared unlawful for any person to kindle, start, maintain, or otherwise produce or propagate a permitted fire within the city limits without following and observing all of the conditions and requirements contained in the burn permit issued by the fire chief or
- (c) Imposition of penalty for violation of open burning ordinance. Any person found to be in violation of this section shall, upon a first conviction, be punished by a fine of at least \$100.00 or imprisonment for up to ten days, or both such fine and imprisonment. Any person found to be in violation of this section a second time within one year shall, upon conviction, be punished by a fine of at least \$200.00 or imprisonment for up to 30 days or both such fine and imprisonment. Any person found to have been in violation of this section a third time within a one-year period shall, upon conviction, be punished by a fine of \$500.00 or by imprisonment for up to six months, or by both such fine and imprisonment. For the purposes of this section, a second or third offense shall be measured from the date of the conviction on each previous violation and not the date upon which the events which led to the conviction occurred.
- (d) Exceptions.
  - (1)Recreational fires. A person shall not be in violation of this section where they start, maintain or keep a fire or open fire which is used for cooking food or for recreational purposes and which burns only charcoal, coal, and/or firewood so long as the fire is started, maintained, and kept in a steel, metal, or masonry container, such as a barbeque grill, fire pit, or outdoor fireplace which is designed for the purpose of containing fire. Any fire which causes the combustion of any other material, including but not limited to, paper, trash, garbage, vard waste, vegetation, leaves, heavy oils, plastic, rubber, paint, construction debris, and other refuse, shall not be exempted by this section.

# Chasing Our Tales IXX

Can you believe this is our 19<sup>th</sup> visit with Chasing Our Tales? With this installment, we will begin to set the stage for the final battles of the First Creek War in Alabama. We will conclude our discussion of the First Creek War with visit number 20 or 21 of Chasing Our Tales. At that time, we will take a hiatus from Chasing Our Tales until sometime later next year. Other articles will fill this space in the Woodmere News until that time.

After the battles of Burnt Corn and Ft. Mims, volunteer armies from the Mississippi Territory and from Tennessee and Georgia combined with friendly Choctaw and Creek warriors began to march into the Alabama

Territory to attempt to quench the uprising of the Red Stick Creeks and protect the settlers in the territory. In our previous visit, remember that General Claiborne pushed into Alabama from Mississippi and eventually engaged the Red Sticks at the Battle of Holy Ground. Meanwhile, General John Floyd was advancing into the territory from Georgia in an attempt to drive a wedge through the center of the Creek Nation. At relatively the same time, General Andrew Jackson was entering the Alabama Territory from Tennessee with a group of volunteers. Joining Jackson near present-day Huntsville was General John Coffee (ref: present-day Coffee County) with another group of volunteers, mostly cavalry. With these Tennessee Volunteers was none other than Sam Houston and Davy Crockett.

Jackson and Coffee built Ft. Strother on the upper Coosa River about 30 miles south of present-day Gadsden. On November 3, 1813, Coffee,

with 900 cavalrymen, including Davy Crockett, attacked the Red Stick town of Tallushatchee located about 15 miles to the east of Ft. Strother. One group of the cavalry formed a skirmish line to the left of the town and another group formed a line to the right. A third group advanced into the center of the town to engage the enemy and then quickly fell back as the Red Sticks pursued them directly into the trap. The battle at Tallushatchee resulted in the death of about 186 hostiles and the capture of many others.


At the time of the attack on Tallushatchee, 154 friendly Creeks plus some militia were located at Ft. Leslie near present-day Talladega. While Coffee's cavalrymen were returning to Ft. Strother from Tallushatchee, the Red Sticks attacked Ft. Leslie/Talladega. The friendly forces at Talladega were outnumbered and surrounded. Total destruction seemed imminent as the Red Sticks laid siege to the fort. The friendly Creeks and miltia at Talladega desperately needed the help of Jackson and the Tennessee Volunteers. A friendly Creek warrior at Talladega wrapped his body in a freshly killed hog skin and managed to slip through the Red Stick siege lines to reach Ft. Strother. Warned of the pending disaster at Talladega, Jackson roused his forces consisting of 1200 infantry and 800 of Coffee's cavalry and advanced on Talladega. Jackson's forces surrounded the Red Sticks who were, in turn, surrounding Talladega. The siege was broken with about 300 Red Sticks killed although 700 managed to escape to fight again. Jackson and Coffee's campaigns up until this time had resulted in more than 1,000 Red Stick warriors killed, wounded or captured which would seriously deplete the number of warriors available for future battles.

On November 29, 1813, General John Floyd, with about 900 Georgia militia, advanced into Eastern Alabama from Ft. Mitchell on the Chattahoochee River just south of present-day Phenix City. Floyd and his men targeted and attacked the Red Stick town of Autossee on the Tallapoosa River near the present-day town of Shorter. During a fierce battle, 200 Red Sticks were killed although General Floyd was seriously wounded in

the knee. After the battle at Autossee, Floyd and his forces would retire to Ft. Mitchell to be resupplied and allow Floyd to heal. Floyd would not take to the field again for two months.

In January, 1814, after healing, being resupplied and reinforced, Floyd was on the move again with a force of 1700 men. During the same time, in the north, most of Jackson's Tennessee Volunteers' enlistments had expired and he was able to muster a force of only about 400 men. In spite of this small force, Jackson was on the march and ready to take the offensive again in January.

Floyd's men advanced into Eastern Alabama, pausing to construct supply forts at Ft. Hull and Ft. Bainbridge. Floyd's ultimate target was the key Red Stick town of Tuckabatchee near present-day Tallassee on the Tallapoosa River. Tuckabatchee was the seat of the Creek Nation and an important political and strategic target. As Floyd's force

neared Calabee Creek (near the intersection of highway 229 to Tallassee and I-85), a tributary of the Tallapoosa, the army paused to make camp on a high hill overlooking the Calabee Swamp. Meanwhile, Jackson was targeting the Creek town of Emuckfaw on the Emuckfaw Creek (located a little north of a bend in the Tallapoosa River called Horseshoe Bend). Jackson intended to attack Emuckfaw to create a diversion for Floyd.

Little did Floyd or his men know that their progress and position was being tracked by William Weatherford (Red Eagle) and Paddy Walsh with the Red Sticks. A surprise attack was planned against Floyd with a force of about 1300 Red Stick warriors. Due to a disagreement, William Weatherford did not participate in the attack. During planning for the attack, Weatherford wanted to wait until Floyd crossed the Calabee and strike while the forces were strung out and on the move. Paddy Walsh thought this was too risky and wanted to hit Floyd

while the Georgians were still encamped in a surprise attack. Weatherford left in disgust and refused to participate.

The next morning, January 27, 1814, at about 5:00 a.m., the Red Sticks crept to within mere yards of the Georgia militia through the swamp in spite of the fact that campfires had been maintained all night around the perimeter of the camp to prevent a surprise attack. The initial assault on the camp almost completely overwhelmed Floyd's army. A group of the army led by a Captain Broadnax was cut off from the main force and about to be annihilated if not for the quick action of a group of friendly Yuchi Indian warriors led by a Yuchi (Uchee) Indian named Timpoochee Barnard. The brave Georgians rallied and held their lines. The friendly Creeks accompanying the Georgians had declined to participate in the battle up until this point. The Red Sticks had determined to capture the artillery which was fiercely defended by the Georgians. Eventually the artillery was secured and brought on line and they begin to rake the Red Stick lines with grape shot from the cannons. Shortly a charge was ordered and the route of the Red Sticks was on. The hostile warri-

ors were pursued into the Calabee Swamp by the Georgians, now accompanied by the friendly Creeks.
