### Did You Know?

There are many areas of life where, with a bit of effort, we can reduce the amount of energy we use. Here are some tips from the U.S. Department of Energy for saving energy while driving.

- Idling gets you 0 miles per gallon. The best way to warm up a vehicle is to drive it. No more than 30 seconds of idling on winter days is needed. Anything more simply wastes fuel and increases emissions.
- Aggressive driving (speeding, rapid acceleration, and hard braking) wastes gas. It can lower your highway gas mileage 33% and city mileage 5%.
- Avoid high speeds. Above 60 mph, gas mileage drops rapidly.
- Clear out your car; extra weight decreases gas mileage by 1% to 2% for every 100 pounds.
- Reduce drag by placing items inside the car or trunk rather than on roof racks. A roof rack or carrier provides additional cargo space and may allow you to buy a smaller car. However, loaded roofs rack can decrease your fuel economy by 5% or more.

### Natural Home

The average family spends about \$1,900 a year on home utility bills, yet a large portion of that energy is wasted. However, with a bit of investigating, home owners can find ways to save energy and money on home energy bills. One approach is a Home Energy Audit where everything from user behavior, the age of the home, the climate of the region and even the home owner's billing history are looked at to find where energy is being wasted and propose the best ways to correct them for long term benefit and savings. Some energy home improvements earn tax incentives for the home owner as well.

While there are ideas and techniques individuals can use on their own, home owners may want to bring in a professional, whether by contacting local utilities or hiring a professional contractor to assess the home.

## Street Spam

"Street Spam" is any advertisement posted illegally in any public place. You can help fight this blight! Most laws and ordinances classify these signs as either common litter or abandoned property. As such, they are fair game for removal by anyone. From Chapter 24 of the Code of City Ordinances, please be aware of the following ordinances. These ordinances are applicable to yard sale signs and other such signs attached to utility poles, etc. Such posting of these signs is illegal.

### Chapter 24 - SIGNS

**Sec. 24-1. - Prohibited on public property.** No signs are permitted at any time on public property such as a city street right-of-way and a utility pole.

**Sec. 24-2. - Placing around Court Square Fountain - Prohibited on public property.** It shall be unlawful for any person to place or have placed around the site of Court Square Fountain, on the fountain, fence or on any part thereof, signs of any sort or description.

**Sec. 24-3. - Placing on poles and trees.** It shall be unlawful for any person to post or paste or otherwise to attach any signboard, bill, advertisement or other paper upon a pole erected by any telegraph, telephone, electric light or power company, or to fire alarm poles or to any tree growing on any street in the city, or to any fixed object on city-owned property.

**Sec. 24-4. - Placing on buildings and verandas.** It shall be unlawful for any person to attach any bill, advertising matter or other paper to any veranda or the front of any building in the city.

**Sec. 24-5. - Owners and occupants not to permit certain signs on premises.**

It shall be unlawful for any owner or occupant of premises in the city to permit any fence, house, store, wall or veranda thereon to have pasted, hung or attached thereto any showbill or advertising posters.

**Sec. 24-6. - Defacing or destroying.**

It shall be unlawful for any person to tear down, deface or destroy advertising signs or bulletins in the city without having obtained the consent of the owner of such signs or bulletins, or the owner of the property upon which signs or bulletins are displayed.

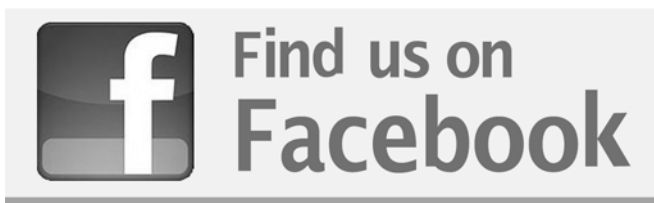
**Sec. 24-7. - Injuring or carrying away professional plates and signs.** It shall be unlawful for any person to take down, deface or carry away any signboard, plate or card indicating the name, occupation or business of any person in the city.

## Internet Safety Tips

- To guard against identity theft, never give out your Social Security number. Treat it as confidential information.
- Commit all passwords to memory. Never write them down or carry them with you.
- When using an ATM machine, make sure no one is hovering over you and can see you enter your password.
- Adopt an attitude of healthy skepticism toward websites that offer prizes or giveaways. Chances are, all that's been "won" is the opportunity to buy something you didn't want in the first place.
- Choose a commercial online service that offers parental control features.
- Tell your children never to give out their address, telephone number, password, school name or any other personal information.
- Make sure your children know to never agree to meet face-to-face with someone they've met online without discussing it with you. Only if you decide that it's okay to meet their "cyber-friend" should they arrange to meet this person, and then the meeting should be in a familiar public place in the presence of a trusted adult.
- Tell your children never to respond to messages that have bad words, are scary, or just seem weird.
- Tell your children never to enter an area that charges for services without asking you first.
- Tell your children never to send a picture of themselves to anyone without your permission.
- Make sure that access to the Internet at your children's school is monitored by adults.

### Do You Have a Hazardous Intersection?

From Chapter 27 and Article I of the Code of City Ordinances, please be aware of the following ordinances. These ordinances are applicable to shrubbery near intersections. Please makes sure that you are in compliance with this ordinance.

#### Sec 27.11 Regulation of hazardous intersections.

- a. In any residence or local business district, no obstruction to vision, including shrubbery or any plant growth between the heights of three feet and 15 feet above street level shall be permitted within 35 feet of the intersection of the right-of-way lines of two public streets or of two railroads' rights-of-way; or of a public street and a railroad right-of-way.
- b. With respect to the planting of shrubbery or with the respect to any existing plant growth on city-owned, county-owned or state-owned property near the intersection of public streets in the city, and in order to avoid traffic hazards and/or traffic accidents caused by blind corners at street intersections, no shrubbery or plant growth, or any obstruction, shall be permitted in that part of the street area between the traveled portion of the street and the private property, within a distance of 35 feet from the intersection corner, or where the vision of motorists or pedestrians is obstructed between the heights of three feet and 15 feet above street level, or a distance and/or height that is reasonable, for the vision as above mentioned is obstructed.
- c. Where there is an obstruction to vision creating a traffic safety hazard on any lot within the corporate limits of the city, it shall be the duty of the property owner after notice of such obstruction to promptly remove the obstruction.
- d. Any notice required to be given under this section shall be given by the chief of police. When such notice is given to a property owner of the existence of an obstruction creating a safety hazard, the property owner shall be conclusively presumed to have notice of the existence of the obstruction.
- e. Any person violating any provision of this section shall be guilty of an offense and, upon conviction, be fined not more than \$200.00 for each offense.



### What You Can Do to Prevent/Reduce Litter

- Set an example for others, especially family, co-workers, friends and children by using trash and/or recycling receptacles and not littering.
- Always have available a litter bag in your car.
- If you are a smoker, carry and use a portable or pocket ashtray. Cigarette butts and filters may take up to 12 years to biodegrade. Some researchers are saying they never degrade.
- If you see litter, pick it up.

## Family Sunshine Center

The Family Sunshine Center has been serving victims and survivors of family violence for 30 years in Autauga, Butler, Chilton, Crenshaw, Elmore, Lowndes and Montgomery counties. Since 1981, they have grown to incorporate services not only to victims with immediate crisis needs, but also those ready to move out of emergency shelter and into self-sufficient lifestyles. They also provide a non-residential counseling center and a community outreach program for prevention education. Most recently, they have added sexual assault counseling to the services they offer.

The staff works diligently to raise awareness about domestic violence and sexual assault and the services that are available to victims. They strive to ensure a network and positive communications among law enforcement, legal services, the court system and other agencies a victim might encounter while exiting the cycle of violence.

How can you help? The Family Sunshine Center offsets significant operational costs with community donations of various supplies. 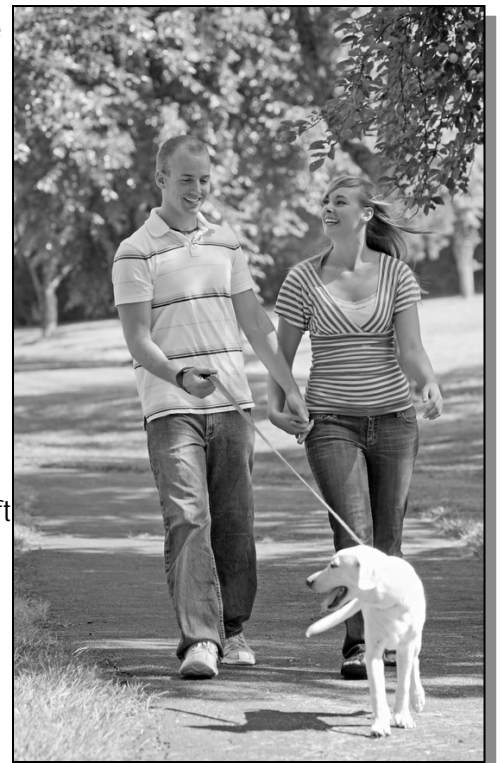


## Pedestrian Safety

Beautiful scenery surrounds the walking trails in and around Woodmere and we know it is hard to resist taking advantage of this amenity. However, it's very important to use caution when walking. Follow these tips to insure you have a safe and fun walk!

1. Always walk on the sidewalk or walking path. If there is no sidewalk and you have to walk in the road, ALWAYS walk facing traffic so that you can see any car that might become out of control.
2. Dress to be seen. Brightly colored clothing makes it easier for drivers to see you during the daytime. At night, you should wear special reflective material on your clothing so that you are easily seen by traffic.
3. Tips for Crossing the Street
  - Cross only at corners or crosswalks.
  - Stop at the curb or the edge of the road. Look thoroughly to the left and right for traffic before you step into the street.
  - Remember when crossing – walk, don't run!
