# **CONDITIONS OF SALE**

We offer a 2 year health/genetics guarantee. We the breeder state to the best of our knowledge, that this puppy is in good health at the time of pick up/delivery if made by Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos. If this puppy is found to have a life threatening illness, diagnosed by a licensed veterinarian within 48 hours from the date of pick-up/delivery, if made by Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, then the buyer may return this puppy to us for:

- 1. A full refund of the purchase price OR
- 2. A replacement puppy of equal value (when one becomes available).

This does not include minor illness requiring short term medication. Proof of examination and diagnosis must be provided to Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos within the 48 hour period to receive the reimbursement of the purchase price of the puppy, or replacement of equal value.

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, reserves the right to obtain a second opinion from a veterinarian of our choice.

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, must be contacted immediately with the name and phone number of the veterinarian responsible for performing the exam. The veterinarian will also need to provide, in writing, all of the results and final diagnosis. Any veterinarian or diagnostic exams and/or costs will not be reimbursed by Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos..

The buyer is aware that owning a dog means necessary visits to a veterinarian and will be responsible for all expenses.

This contract does not cover the following:

- Viral illnesses
- Internal or external parasites
- Infections
- Improper bites
- Giardia
- Coccidiosis
- Kennel cough
- Behavioral issues
- Allergies or skin conditions
- Brucellosis
- Parvovirus

This contract does not cover ailment due to ingestion of foreign objects, food, chemicals, stress related issues, physical injuries, or any illness that may have occurred and/or been contracted after the puppy is no longer in possession of Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos.

# VACCINATIONS AND DEWORMING

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos assures that this puppy has been thoroughly dewormed with *Fenbendazole for 5 consecutive days at the age of* four and seven weeks of age .(please note: when puppies are given deworming medicine.... It is not uncommon to find a worm in the puppies' stool. Do not be alarmed, as this can be a fairly typical response to the medicine.)

This puppy has received his/her first vaccines and health exam by a licensed veterinarian.

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos puppies are given their first vaccines. This does not mean that they are immune to the diseases that they

have been vaccinated against. Your puppy will require a second set of vaccines at twelve weeks of age, and a third set at sixteen weeks of age. Please follow up on all the recommended boosters before taking your puppy out in public. Take your puppy to the veterinarian inside a carrier and do not allow him/her to roam freely in the clinic, or allow other clients at the office to touch your puppy until all required vaccines have been completed. This may seem unfriendly, but it is imperative to your puppy's health. Just remember that others may be there visiting due to a sick animal.

## **HEALTH**

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos certifies that your puppy's parents have both been genetically tested for over 200,000 genetic markers with Embark and the results show a very good bloodline and positive overall health.

I am aware that puppies can have certain common ailments upon coming home. Urinary tract infections, parasites, ear infections, and allergy issues are all common. While we routinely deworm and monitor for potential UTI's and ear infections, sometimes the stress of leaving the breeder causes issues to flare up. I understand it will be my responsibility to treat and care for my new puppy once they leave Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos.

I understand that puppies can have certain ailments and agree to ensure my puppy gets proper care and medication if needed .

The buyer agrees to maintain this puppy/dog in good health, appropriate weight and provide routine preventative care, including but not limited to:

- Inoculations
- Internal and external parasites

The buyer will provide fresh water and has been recommended to feed TLC nutritional dog food. Information regarding what we recommend for food has already been forwarded to you with instructions. Please ensure whatever you choose to feed your dog, that it is meeting all nutritional requirements.

Do not allow your puppy to roam your home freely without being puppy proofed in order to reduce the risk of chewing or swallowing objects. We recommend a crate that your puppy can freely move around in, a puppy exercise pen, or gating off a puppy area in your home for when you cannot supervise your puppy.

ALL PUPPIES ARE SOLD ON A STRICTLY ENFORCED NON-BREEDING CONTRACT

Unless otherwise agreed upon in writing

Any puppy that is purchased from Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, is to be spayed or neutered by the time they are one year of age by a licensed veterinarian. Proof of procedure must be provided via email at <a href="mailto:info@pawzitivelypoodles.com">info@pawzitivelypoodles.com</a>

If the dog has not been spayed/neutered by one year of age, without the written recommendation provided by a licensed veterinarian to wait until a later age for health reasons, the remaining year of the two-year warranty is considered null and void. If no legitimate reason has been provided as to why this dog has not been spayed or neutered, then Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos reserved the right to remove this dog, if we see fit, and will not refund any costs associated with this dog while in the custody of the purchaser.

Severe penalty and legal steps will be enforced against you if you do in fact breed this dog.

The litter(s) of resulting puppies and/or their sales belongs to Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos.

Selling of this dog is prohibited. Rehoming of this dog without written approval from Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos is prohibited. Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, will either approve of the new home, or accept the dog back without monetary reimbursement. A \$10,000 fine if this contract is breached.

There will be a \$10,000 (CAD) fine in place for breach of this non- breeding contract.

### WARRANTY

#### Genetic disease

A warranty against serious, life threatening genetic diseases until two years of age. Should a genetic disease be discovered during this time, that will shorten the life or greatly alter the livelihood of the puppy/dog.... Then Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, will require that the puppy/dog is returned in order to provide a replacement puppy of equal value when one becomes available. Proof of examination and diagnosis must be provided by two separate licensed veterinarians that are of no correlation.

Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, <u>is not</u> responsible for any of the veterinarian costs.

# **SHIPPING**

Pawzitively Poodles, and Pawzitively Mini Bernedoodles provide the opportunity to receive a puppy from us for those who are located within a fairly distant location. We will accommodate you by preparing the puppy in its crate and taking the puppy to the Toronto airport. .However, "all" arrangements/booking/details/costs are the sole responsibility of the purchaser. Pawzitively Poodles, or Pawzitively Mini Bernedoodles will not be held responsible or accountable for any possible errors, mishaps or damage to either the puppy or crate after the puppy has been relinquished to the employee/employees of the Toronto airport and is no longer in our care. Adorable Little Chipoos puppies are not available for flight. They are too small and delicate.

Please be mindful to your puppy and understand that your puppy may or may not be exhibiting fear, anxiety or cautiousness and confusion. Your puppy was just taken from the only environment he/she has known, away from mom/siblings and taken on a long drive, and has possibly been on a plane for a long period of time. This journey has consisted of many new sounds, smells and people which to a small puppy is very overwhelming. Your puppy will need lots of love, understanding and compassion to help him/her settle into its new home.

If the puppy/dog is to be rehomed, this contract/warranty cannot be transferred or assigned by the buyer and will become null and void. A new contract will be created for the new approved owner.

If this puppy is purchased with the intention of being an ESA (Emotional Support Animal), Therapy, or a Service Dog, Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos, will not be held responsible for the training of this puppy or the training the puppy may receive from a professional dog trainer. Pawzitively Poodles, Pawzitively Mini Bernedoodles, or Adorable Little Chipoos has done due diligence in helping to choose a puppy that fits the temperament. There is no guarantee that this puppy will become a working dog.
