



A Note from your Treasurer



Greetings United Women in Faith,

Fall is in the air. Here we are in November with the weather turning cooler and the leaves turning color. We can also tell it's fall by all the pumpkin drinks, pastries, and desserts that are available in the stores.

First of all, I want to emphasize my great appreciation for your efforts to meet our pledged goal. East District and Conference appreciate the money that has been sent in for our Mission work.

As of the end of October 2023, only 24 of the 44 active local organizations have submitted their remittances for Mission Giving. As a friendly reminder to those who have not yet paid towards their 2023 pledges, I urge you to please check your records and submit your remittances by the end of November. Every little bit adds up and helps in Mission Giving. The 2023 East District pledge is \$50,000. We have received \$25,585.36 as of the end of October. We need an additional \$24,414.64 to meet our goal. Let's end the year with a bang and send those final payments in for 2023.

Treasurers should be finalizing their End-of-Year reporting, and the form is included in this newsletter. Each local organization will also be receiving an email regarding the deadline for the End-of-Year report and final remittance. The 2023 End-of-Year remittances need to be sent to me and received by **December 5, 2023**, accompanied by a completed Remittance Form. Write out your checks to East District United Women in Faith, and please mail checks and forms to me early so I receive it by the deadline date. Any remittance received after the deadline will be processed for 2024.

Organizations that would like to receive the 5 Star Certificate must have submitted money into the categories of (1) Pledge to Mission, (2) Special Mission Recognition, (3) Gift in Memory, (4) Gift to Mission, and (5) World Thank Offering. To receive the 60/40 certificate, the Year End Report must also be submitted to the District Treasurer by **December 5, 2023**. If you would like to confirm that your organization meets the requirements, you can email or call me at the information below.

Treasurer Training will be held in January 2024. The date and information are not available yet. Please fill out the attached form to let me know who your 2024 treasurer will be. I will send the training information to the Treasurers when the information is available.

Ban Assault Weapons ...

My dear sisters in Christ:

If you believe that gun violence is alarming in our country. Then contact your elected officials. Let them know how you feel. There is a need for legislation.

As United Women in Faith we can take action by writing letters, postcards, emails, or phone our elected Senators. These lawmakers need to receive as many letters (and weekly calls) as possible from their constituents to show them this issue isn't going away.

Mention you are a member of United Women in Faith. Remember that as UWF we believe "Love in Action can Change the World". Be respectful.

Share a personal story or whatever is important to you & your family. Add or omit what you are comfortable with.

Let them know you want to ...

• Reinstate the ban on assault rifles (We already had this from 1994-2004 signed by President Clinton). Assault weapons were designed for military and law enforcement to quickly do as much bodily damage as possible, even death, to as many as possible. There is a reason we never see photos - either they are too gruesome or the bodies no longer exist.

• Ban high-capacity ammunition magazines, which have no place in civilian life.

• Closes dangerous loopholes that unlicensed gun sellers have exploited for decades to sell guns online and at gun shows without running background checks.

- Raise the age limit for buying a gun to age 21.
- Common sense background checks. including improving and expanded to cover private sales and gun shows.
- Ten day cooling off period
- Red Flag Laws nation wide
- Make gun trafficking a federal crime, with stiff penalties.

• Fund research and care for persons with mental illness, impulse disorders and substance abuse issues to prevent violence.

- Ban civilian full-body armor.
- FUND the ATF, so we can have better enforcement of new laws and ones already on the books

• Hold the gun industry accountable and ensure there is adequate oversight over the marketing and sales of guns and ammunition.

• Require micro stamping technology on all firearms sold, bought or delivered, in order to improve bullet tracing by law enforcement.

• Fund research and care for persons with mental illness, impulse disorders and substance abuse issues to prevent violence.

• Engage responsible gun dealers and owners in solutions.

The gun lobby tells us that the only way to make us safer is to carry more guns. I believe that is wrong. Uvalde, Texas had armed guards. Louisiana Rep Steve Scalise was shot playing softball, Arizona Rep Gabby Gifford, President Kennedy, President Reagan, and James Brady were surrounded by the U.S. Secret Service, the best-trained professionals in the world, when they were shot.

Enough is enough. Now is the time for change and action.



The Election Process-

Conferences elect 2 nominees and an alternate at their Annual Meeting in 2023.

♣ Each jurisdiction elects the designated number of national directors at their 2024 Jurisdiction Meeting. (Note: Western Jurisdiction – 2)

↓ June 23, 2024: Extended Governance Committee selects 1 director per jurisdiction to serve on the national Committee on Nominations.

All nominees not elected at jurisdiction meetings will be considered by the national Committee on Nominations for service as an additional member of the board or as a member of the Program Advisory Group.

4 A national director is also a member of the Program Advisory Group.





Frequently Asked Questions on United Women in Faith

Why are we taking a new operating name?

The name United Methodist Women was adopted in 1972, signaling a change not only in the life of the church but in the lives of women and how they could organize for mission.

Over the past 50 years, we have experienced vast change in how women live their lives and choose to engage the world in faith as well as great changes in the life of the church.

It is time to adopt a name that reflects how women are living and engaging their faith in today's realities.

Our new name is part of an overall move to refresh our organization that includes a new look, new feel and new and improved programs. We will be able to better nurture our current members while welcoming into our sisterhood new women who want to put their love in action. The new operating name is also welcoming to women whose local churches may choose to align with another denomination or who are already members of other denominations.

Are we still a part of The United Methodist Church?

Yes! We are still the only official women's organization of The United Methodist Church and our corporate name will remain United Methodist Women.

How were these decisions made?

As part of our strategic planning guided by the Board of Directors, and the Program Advisory Group (PAG), we have conducted an enormous amount of research over the past five years. The new name, programs and program innovations are fruits of that research along with prayerful efforts to discern the times for our organization. The member-elected United Methodist Women Board of Directors, along with input from the PAG, has guided the organization throughout this process.

We've conducted surveys, focus groups and interviews with more than 24,000 United Methodists and women of other denominations and Christian traditions. The changes and programs are data informed and tested to address the needs and life stages of current and future members.

Will these changes impact me and my local unit?

All of our traditional structures on the conference, district and local levels—circles included— remain intact. These new tools and programs are additional options available to you and your unit to help you better nurture current members, recruit new members into the organization and manage your unit's finances.

United Women in Faith has a mission statement. What about our Purpose?

The Purpose for the local church remains the Purpose as it appears in The Book of Discipline of The United Methodist Church 2016 (¶256.5.3). The core of our work remains the same: changing the world through faith, hope and love in action. The United Women in Faith mission statement—written by board executive committee members, PAG representatives and assigned staff—is a refreshed expression our core principles.

Can we remain members, stay connected and join another local unit if our church leaves The United Methodist Church?

Yes. United Methodist Church membership has never been required for United Methodist Women membership. Bylaws changes allow for women to be involved and be leaders in our organization even if they become affiliated with another denomination. Our new name captures this inclusivity.

Where can I learn about all of the changes underway in our organization?

What do these changes have to do with "new wineskins?"

United Methodist Women—now United Women in Faith—is again saying yes to being part of what God is doing in the 21st century by creating new ways for women today to gather for faith, sisterhood and action for women, children, and youth.

In other words, we are making new wine and new wineskins to fulfill our role in God's mission today. We tap Jesus' use of the metaphor in Mark 2:22 to explain the need for change to help us share with members the new tools, programs, and exciting changes on the horizon for our organization.

What new tools and programs are coming?

The new tools and programs that will rollout throughout 2022 include:

A new, easier to navigate website. The new website will have a homepage designed to pique the interest of women new to our organization and start them on a journey to membership. The homepage will also include a special portal where members can log in to access resources specially designed for them.

Templates for Soul Care retreats. A pilot member recruitment program will be debuted through which current members invite nonmember friends to themed retreats specially designed to nurture our bodies, minds and souls.

Innovations to Mission u. Beginning in 2022, Mission u will be introducing new curricula each year—one for children, one for youth and one for adults—all focused on a shared biblical theme that incorporates spiritual growth, contemporary issues and how these show up in various geographic areas. The new Mission u curricula will be more accessible and adaptable for use in small groups, local churches, vacation Bible schools, retreats and other settings. Through these vibrant, relevant, justice-oriented and biblically centered curricula, Mission u will continue its commitment to learning together for the transformation of the world and expand its impact.

A new national membership option. This option will enable women to join our sisterhood via our new website. They will learn about and be able to participate in programs and events online or in person. Of course, on-line options and resources will also be available to existing members who already participate in circles and units. More targeted giving options. Members and nonmembers alike want more options to target their financial gifts to specific programs areas such as Spiritual Growth, National Mission Institutions or international work. (continued on next page) New tools for conference and district treasurers. New tools, like Vanco Faith, will be available to enable treasurers to manage, collect and distribute conference and district finances electronically.

Innovations in the Leadership Development Days programs.

New and improved resources:

Mighty Networks, an exciting new online platform where members can connect, and engage new resources like the Program Resource and Mission u curricula.

The Daily Prayer Guide, an updated replacement of the Prayer Calendar, which offers opportunities for daily devotion and connection.

What does the rebranding have to do with these changes?

Brand is a term most often associated today with commercial marketing, but in reality, everyone has a brand. Brand is just a term to describe what people can expect to experience when they encounter you. "Branding" are the things we do—our look, our actions, our messages—that help let people know who we are and what we consistently deliver.

Rebranding United Methodist Women means we are clarifying the way we tell our story and updating our programs, resources and outreach efforts so that it is easier to see who we are. The research showed us that our values, our commitments, and the work we do in the world is attractive to many women who are not yet members, including women of diverse ages, racial ethnicities, cultural backgrounds and life stages. Our welcoming new brand will highlight who we are.
