## **New Member Application Procedure**

- 1. A prospective applicant must present all of the following items for consideration as a member:
  - a. This completed form
  - b. Proof of citizenship by means of one of the following:
    - 1) A valid U.S. Passport
    - 2) A Government Issued Birth Certificate with a raised seal
    - 3) A Certificate of Naturalization
  - c. An original CORI check at your expense (only if the applicant does not have a sponsor or current license to carry)
  - d. Payment for the Dues, Initiation, and Work Assessment Fee (reference the payment schedule on Page 1)
- 2. You must arrive prior to a regular Monday night general business meeting at 6:30 PM to be interviewed by the Board of Directors.
- 3. At this time you will be required to present yourself to the members present.
- 4. Upon acceptance or denial you will be notified by the orientation officer to setup an orientation or in the case of denial to pick up your documents and returned fees.
