Chairman's Report
June 2025

General Topics

- Requested and held two meetings with Kirsten James from Hey & Associates (May 22nd and June 11th)
 - Gained a deeper understanding of Hey & Associates' capabilities and history with the WWMD.
 - Received and reviewed copies of past proposals to the WWMD.
 - Discussed a range of WWMD priorities including APM, dredging, the removal of submerged hazards, and job requirements for a potential executive director position.
 - Found Kirsten James to be a valuable partner being knowledgeable and willing to assist on many of the topics discussed.
- Received a phone call from WWMD commissioner Scott Uhler on June 4th.
 - Scott informed me he is looking to step back from the WWMD Board citing increasing demands of his career obligations which he feels are restricting responsiveness to current district needs.
 - Seeking board input on potential individuals to fill the vacant commissioner position

APM

- Attended the [Aquatic Weed Harvesting Seminar](#) at Aquarius Systems on May 16th.
 - Members of the WWMD's APM mechanical harvesting crew also attended.
 - Valuable presentations on aquatic invasive species, the operations and safety for our Aquarius harvester, and the WDNR's proposed changes to APM rules (NR107/NR109)
- Participated in a meeting on May 19th with the Craig Helker from the WDNR to kick-off our 2025 mechanical harvesting season.
 - Meeting included Bill McCormick and the members of the WWMD mechanical harvesting crew from Midwest Irrigation.
 - Craig provided a good overview of the guidelines for mechanical harvesting on our waterway.
- Responded to several inquiries from riparian owners concerned about the weed growth
 - Reminded them of the treatment delays this year due to the point intercept studies required as part of the APM Plan Update project. Explained that approved herbicide treatments should be completed by the end of June.
- Used *Ink Spot of Wisconsin* in Waterford to provide the APM mechanical harvesting crew with a fresh supply of blank copies of the APM Equipment Logbooks. \$105 for 100 copies or each logbook.

Ecosystem Restoration

- Had a phone conversation with WWMD commissioner Grant Horn on June 3rd.
 - Discussed the current state of his pursuit of a drawdown dredging initiative and his recent correspondence with the WDNR on this topic.
 - Shared my views regarding potential value in finding a qualified firm or individual that would be dedicated to developing and managing the overall dredging initiative from start to finish

Town of Waterford

- Provided the WWMD update at the June 9th Town Board meeting; substituting for Bill McCormick who was on vacation.

Village of Waterford

- Met with village president Adam Jaskie, village administrator Zeke Jackson, and former village president Don Huston on June 9th.
 - Gained foundational understanding of the Village's views and history of working with the WWMD.
 - Started dialog regarding the WWMD's continuing interest in the quarry site. Agreed to a future meeting to include Dan Schultz for further exploration of the WWMD proposal and its benefits.

APM Chairmans Report

June 18, 2025

General Report:

Wisconsin Lakes and Ponds as part of the APM plan update started to perform their P/I surveys around the waterway on Monday June 16th and they are hoping to wrap those studies up by Wednesday June 18th, however during the study they discovered a new invasive plant species on our waterway called Starry Stonewort. I have a phone call into Craig Helker from the WI-DNR to better understand what this means for us and our waterway. In talking with Jim Scarl who found the plants he said that other waterways that currently have these plants are Wind Lake, Little Muskego and Lake Geneva. Jim indicated that there are special herbicides that can address these plants, however the WI-DNR has not yet approved any herbicides for use in controlling or eliminating the plants in the state of WI. This a relatively new invasive plant species to come into WI.

Mechanical Harvesting:

Mechanical harvesting this year got off to a slow start with the delay in receiving the special 1-year permit and due to weather we didn't really get started until Thursday May 23rd. However, with that being said the crews have been working hard and they have already made it once around the waterway. During the week of June 23rd, they will be addressing the main navigation channels as Wisconsin Lakes and Ponds begins applying herbicides to the navigation lanes. We have experienced a few breakdowns on the equipment with the transfer barge having an issue with one of its spud anchors where a key way became worn due to a crack in the motor bracket, which then caused the sprocket to lose some of its teeth. Aquarius has been called to help us fix this issue.

Log sheets are being filled out by the harvesting crew and daily inspections and maintenance such as greasing is being done weekly along with weekly cleaning of the equipment every Friday afternoon.

Motion: Move that the WWMD pay for a spare trailer tire purchased from Inland Lakes in an amount not to exceed \$450.00.

Motion: Move that the WWMD pay Aquarius for their help in addressing and fixing the transfer barge spud anchor in an amount not to exceed \$500.00.

Herbicide treatment:

Herbicide treatments on Lake Tichigan are scheduled to start on Thursday June 19th and will continue to the rest of the waterway during the week of June 23rd. ProcellaCOR is scheduled to be applied in Buena Lake on Monday June 23rd.

Nonetheless, I have been working hard since our last meeting at further developing a plan and bid package for draw down dredging. On Thursday, June 5th I sent the email to the DNR and copied the town chairman, village president, and Racine County supervisor Greg Horeth as well as our own WWMD chairman. As you all saw from the draft email, I requested the DNR to come out and take a survey with me via kayak or canoe to fully understand and appreciate our issues.

I appreciate my fellow commissioners' feedback in advance of me sending that email. In a feedback discussions

with our chairman, he expressed his desire to have a professional to help alleviate some of the burdens on me through a third-party who is skilled and has similar project experience and also the ability to lead this project as a 'quarterback' and take us from where we are to completion. Scott Uhler has expressed similar concerns repeatedly in the past.

On Monday, June 9, I had a conversation with Brian Valleskey of Geosyntec to discuss him being that quarterback. We discussed drawdown dredging at length and Geosyntec's recent experiences right here in Wisconsin of doing drawdown dredging. Brian is a somewhat local guy, as he lives in Mequon, and he will be meeting with me here in Waterford on Tuesday, June 26 to discuss next steps. We will not be invoiced for his time at this meeting.

I have been working with the DPW and the PD on deploying more buoys and I received more assistance from riparian Gary Hay in the process. We did find two more boxes of new lights for the boys in the storage unit.
