HARVESTING TRANSPORT OPTION TO PURCHASE

The undersigned parties, Eagle Lake Management District (ELMD) and Waterford Waterway Management District (WWMD) do hereby enter into this agreement as of the date set forth below.

WHEREAS, ELMD is owner of an Aquarius Systems Model T-45 Transport, Serial #UR514 Harvesting Transport Barge, and no longer has need for the barge, and

WHEREAS, WWMD has a need for the barge and desires to lease the barge with the option to purchase.

NOW, THEREFORE, the undersigned parties do hereby stipulate and agree as follows:

- 1. That beginning January 1, 2022, WWMD shall lease the aforementioned barge from ELMD for an annual payment of \$24,000 over a five year period ending in 2026.
- 2. That said payments shall be made by WWMD to ELMD no later than May 15 of each year.
- 3. That WWMD shall be responsible for all repairs and maintenance of the barge so that it remains in good and operable condition. Failure to maintain or repair shall be deemed a breach of the lease subject to the right of replevin.
- 4. That during the term of the lease WWMD shall insure the barge for, at the least, its fair market value, and shall also maintain liability insurance for its use in an amount not less than \$1,000,000. ELMD may also continue to maintain some level of insurance commensurate with its outstanding loan on the barge.
- 5. That ELMD shall be responsible for continuing to make all secured payments associated with the barge in a timely manner until said obligation is paid in full.
- 6. That during the term of the lease ELMD shall continue to store the barge during non-use season at its expense, and WWMD shall be solely responsible for transportation of the barge to and from the storage facility.
- 7. That WWMD shall hold ELMD harmless from any and all claims or causes of action which arise from WWMD's use of the barge, or while said barge is under their care and control. This hold harmless contemplates that WWMD shall have the exclusive use of the barge during the term of the lease, and that ELMD shall have no say in the use or management of said barge.

- 8. That upon payment of the final installment contemplated herein, ELMD shall sign any and all necessary documents, including a bill of sale, transferring ownership of the barge to WWMD.
- 9. That in the event of any default on the part of WWMD under the terms of this lease, ELMD shall give written notice of the nature of the default, and WWMD shall have 30 days in which to correct the default. In the event the default has not been corrected in a timely manner, ELMD shall have the right to the return of the barge to their care and full ownership. All payments made by WWMD up to that date shall be deemed in the form of lease payments, and shall not give WWMD any interest in the barge, secured or otherwise.
- 10. That during the term of this agreement, both parties agree to exchange any necessary documentation or information, and allow inspection of the barge, at reasonable times on reasonable notice to ensure compliance with the terms of the agreement.
- 11. That any and all notices required to be given under the terms of this agreement shall be delivered as follows:

12. That this agreement represents the entire agreement of the parties, and any discussions or negotiations which occurred prior to the date of execution of this agreement are intended to be fully incorporated herein.

HARVESTING TRANSPORT LEASE

The undersigned parties, Eagle Lake Management District (ELMD) and Waterford Waterway Management District (WWMD) do hereby enter into this agreement as of the date set forth below.

WHEREAS, ELMD is owner of an Aquarius Systems Model T-45 Transport, Serial #UR514 Harvesting Transport Barge, and no longer has need for the barge, and

WHEREAS, WWMD has a need for the barge and desires to lease the barge with the option to purchase.

NOW, THEREFORE, the undersigned parties do hereby stipulate and agree as follows:

- 1. That ELMD shall lease the aforementioned barge to WWMD for the 2021 harvesting year.
- 2. That WWMD shall pay ELMD the sum of \$5,000 for use of the barge for said period.
- 3. That WWMD shall additionally pay for any needed maintenance or repairs stemming from their use of the barge.
- 4. That both parties shall maintain insurance on the barge until such time as this agreement is concluded.
- 5. That WWMD shall return the barge on or before September 17, 2021, at its own expense, and ELMD shall store the barge in their existing storage facility.
- 6. That WWMD shall present the intended lease and purchase of the barge for \$125,000 to begin in 2022, at which time, if approved by the members, shall enter into a long term lease/purchase agreement.
