Fairfax County Board of Supervisors' Proclamation

Whereas, Fairfax Pets On Wheels, under sponsorship of the Department of Family Services' Fairfax Area Agency on Aging, in cooperation with nursing homes and assisted living facilities in Fairfax County, provides pet therapy services to older adults; and

Whereas, petting animals has been medically proven to assist in curtailing the loneliness, depression and withdrawal often associated with residency in a nursing facility, enabling older adults to recall happier times; and

Whereas, Fairfax Pets On Wheels, begun 25 years ago, has grown from 20 volunteers and their pets to more than 300 volunteers and their pets; and

Whereas, Fairfax Pets On Wheels – an all-volunteer program – donates more than 8,000 hours of pet visitation annually; and

Whereas, the American Kennel Club has approved Fairfax Pets On Wheels as an AKC-recognized therapy dog organization;

NOW THEREFORE BE IT RESOLVED, that the Fairfax County Board of Supervisors, on behalf of all residents of Fairfax County, does hereby proclaim October 2012 as Fairfax Pets On Wheels Month in Fairfax County and does extol, thank and congratulate it on the occasion of its 25th Anniversary for outstanding and noteworthy service to older residents of Fairfax County.

Report on the State of FPOW 2011—2012

Fairfax Pets On Wheels, Inc., saw yet another very busy and successful year during Program Year 2011 – 2012. I'll recap the year in brief: (Continued on Page 2)

- 1. More than 7,600 hours of tail wagging and unconditional love were provided by over 300 volunteer teams to 14 long-term care facilities having more than 1,500 beds. During this program year we expanded by two facilities, Arleigh Burke Pavilion in McLean and Sunrise in Reston. A special thank-you to Madelynn Arnold, Deb Zelten and Kathi Baker for overseeing and implementing this monumental effort.
- 2. We once again had our United Way application accepted for inclusion in the United Way of the National Capital Area campaign (remember to designate 8907 when pledging).
- 3. We were included in the Combined Federal Campaign (designate 51148 when pledging) and the Combined Virginia Campaign (designate 8098).
- 4. We spoke at numerous United Way fundraising events and had information booths at Reston Pet Fiesta; the National Capital Cat Expo; the Positive Aging Conference at the Northern Virginia Jewish Community Center; the Office of Naval Intelligence; Sheppard Center in Annandale; United Way of the National Capital Area; Vienna Office; and the Girl Scouts of America in Alexandria.
- 5. We hosted our 16th Annual 3K Paws for a Cause Walk in October 2011, where we raised over \$15,000 and had 226 walkers brave the weather!! Plans are well underway for our 17th Annual 3K Paws for a Cause on Sunday, October 7.
- 6. In June 2012 we held our 25th Anniversary and Annual Volunteer Appreciation Event in Reston at Frying Pan Farm Park. A special thankyou to Kathi Baker for planning this wonderful and memorable event, to Robin Burkett for taking the great pics for our FPOW pet trading cards and pet portraits, to King Creole Catering for great food,

- and last but never least, FPOW's official DJ Michael Galvin for providing foot-stomping and tail-wagging entertainment.
- 7. We awarded the Latshaw Award to long-time FPOW volunteers Joan Violate and Patricia Leader for their continuous commitment to the program. Emily Atkinson, activities director at Iliff Nursing Home, was also awarded the Latshaw for her continuous and unwavering support of FPOW and Iliff's residents.
- 8. The Shauna was awarded to Lolly Davidson, Jill Davidson's six pounds of pure Pomeranian panache, who visits Commonwealth Care Center AND lends her very able paws to the FPOW office!!!! Lolly has been an active volunteer since October 2007 with her spirited and elegant "twirls" and her paws-i-tively precious "high fives." Lolly delights!!!! Well done, Lolly!!!!
- 9. A Rally was featured and was a huge hit at this year's volunteer appreciation event!!!!!!! More than 25 dog and handler teams took on the Rally course at the picnic, and they all did a fabulous job! A Rally course can contain from 10 to 20 stations. At each station the team has to perform a specified exercise. The higher you go in Rally, the more challenging the exercises become. Our 11-station course contained mostly Novice-level stations sits, stays, various heeling exercises, and the like. Thank you, Liz Breyer, for this wonderful educational event.
- 10. We honored 35 Hours Award recipients: 17 Bronze recipients (50 to 74 hours), 5 Silver recipients (75 to 99 hours) and a whopping 16 Gold recipients (99-plus hours), Volunteers, job well done!!!!!
- 11. This year being our 25th Anniversary, we also rewarded years of service. We recognized 31 for five years plus, 13 for 10 years plus, five for 15 years plus, four for 20 years plus, and three for 25 years plus.
- 12. The Temperament Testing Committee has continued its work on strengthening and perfecting our new canine, feline and rabbit tests. We've been working under the new testing guidelines for more than a year. During this program year alone, 147 pet teams passed temperament testing. A hat-tip to our Temperament Testers and pet teams!!!!!
- 13. The American Kennel Club has certified FPOW as an AKC-recognized therapy dog orga-

- 14. We conducted monthly FPOW orientation sessions and temperament tests for new volunteers.
- 15. We sponsored our 7th Annual Pet Photo Contest, "Innocent Until Proven Guilty" pictures are proudly displayed on our website at **www.fpow.org/photo**. The winning picture can be found on page 10.
- 16. We continue to recruit and train additional volunteers for the FPOW Speakers' Bureau the FPOW-sanctioned group of qualified volunteers who speak with a united voice to represent the program and respond to a growing need for speakers on our program.
- 17. Kris Higgins, a graduate film student at American University, shot the short and very moving film "Almost as Much as the Dog" which captures the emotion and spirit of pet therapy.
- 18. We have produced a budget that not only ad-

dresses the program-year needs but also the strategic needs of the program.

- 19. In spite of the sluggish economy, FPOW's donations have held steady.

How to Find a Trainer

In the beginning of the new year, there is an increase in calls to AKC Canine Good Citizen from puppy/dog owners looking for trainers. They want us to tell them how to find a trainer. We refer to our AKC Canine Good Citizen evaluator/instructors, but in some cases, there may be more than one person in a town from which the dog owner can choose.

We talk to the prospective new student about how important it is to find the right match; we warn against choosing a class simply based on cost or because it is nearby.

Here is a checklist we've developed for choosing a trainer:

Choosing the Trainer for You and Your Puppy/Dog

Ask the instructor some questions. Examples of questions might include:

- 1. How long have you been training dogs? How long have you trained puppies?
- 2. What kinds of classes do you teach?
- 3. Have you put any titles on your own dogs?
- 4. What dog sports do you participate in or have you participated in?
- 5. What is your basic philosophy of training?
- 6. What kind of equipment will we be using in class (e.g., collars, etc.)
- 7. Do you use food rewards? Corrections? If so, please tell me about these.
- 8. Are all sizes of puppies together? Do you have play groups?
- 9. Do you know your dropout rate? How many students finish your CGC/S.T.A.R. classes?
- 10. After the beginning class, do many students go on for additional training?

Visit a puppy class and observe the instructor. What do you think about:

- 1. The instructor's skill level in teaching humans (adult learners).
- 2. The instructor's knowledge of dogs/puppies. When you are asking the instructor questions, ask about any credentials, special certifications or training the person has. But, remember, people can pass a test and still not be able to train a dog. You'll get a lot out of the direct observation as to whether or not an instructor can teach a dog or teach a person to teach a dog.
- 3. The instructor's communication style with students pleasant, reinforcing vs. bossy and sarcastic.
- 4. Organization of the class. How long on each topic, how many students/puppies/dogs?

- 5. Curriculum does it teach all you want to learn?
- 6. Do the puppies/dogs look happy, eager to learn vs. bored or nervous?
- 7. Do the human students look happy, eager to work, or frustrated?
- 8. Instruction is presented and sequenced so that students and dogs are having success.
- 9. Teaching methods do you spend all the time listening to the instructor talk or is this an active learning class?
- 10. The instructor's ability to handle any behavior problems or student questions.
