worked hard to get what it needed. Then I received an email from another volunteer saying she was glad I had agreed to be the "guest speaker." It seemed a bit of a leap but because this is FPOW I accepted it. The only problem was I decided that

I have to be very careful about semantics because a few years ago I volunteered to help with my high school 50th reunion and then started getting phone calls and emails that I was in charge!

So anyway I am here, very happy to see old friends and acquire new ones. And to see that the program is still attracting compassionate, caring people. When I started in the fall of 1994 we were in nine facilities. Today you are visiting in 17 facili-

ties. To me that is a great deal of growth AND WORK. Getting a facility educated about FPOW and learning their expectations, find a liaison, and

recruit volunteers is no small task. Kudos to all who have participated in seeing that this happens.

In the thirteen years I worked for Fairfax Area Agency on Aging I was always amazed of the number and commitment of the volunteers. We went through some tough times such as getting on board with insurance and changing computer systems I don't know how many times but we always made it. The program is very labor intensive – all the paperwork – but all I had to do was visit one of the facilities during the time FPOW was there and I would go back to the office saying no matter what it takes to run this program it is worth it!

This program is unique in many ways. It gives you and your four legged buddy an activity to do together. Your visiting makes people feel good, happy, and that they manner. The residents you visit are the forgotten population in our society. You give them an opportunity to feel special. Many have had pets in the past and it gives them a chance to reminisce about the pets they use to have. It often gives the

residents who don't participate in any of the activities of the facility an opportunity to share bits of their lives. As we all know, there is nothing like the touch and attention of a pet.

Many of the residents either don't have families or family that visits. Often their friends have passed away or are unable to visit. So think about how their lives have changed. It can't be easy and this is only the social part of their lives. Then add on the physical and ones life has been

turned upside down. The lucky ones are those who have families who care. And those families are the ones that often let us know how important FPOW is to their loved one.



FPOW is a program that draws attention. When I wear my FPOW T-shirt I am stopped and asked what it is. It's a unique program and educating people about what it is and the benefits to the

volunteer teams and the residents always brings a positive response. Planting seeds about how one can volunteer with their pet and at the same time bring joy to those who are often written off as not being a part of our community.

By visiting these residents this is a chance to learn about the past, their accomplishments and way of life. Everyone wants to feel they contributed to society no matter how big or small and this gives them a way to share their stories. They are much more than that person in the bed or wheelchair. Your pets are the best conversation starters I know.

Making time to visit is not always easy. You have to be sure your pet is ready and then drive to your facility. Sometimes you are tired and just don't want to make the effort to go but then you think of your favorite residents or the one who is just beginning to respond to you or the one whose family has asked you to visit because their loved one is lonely and you get up and go because you don't want to let these people down. We all have a reason we volunteer. We are just glad you picked FPOW.

#### Paws for a Cause

Once again, FPOW's sole fundraiser, Paws for a Cause, was held on a beautiful Sunday afternoon. The 22nd annual event was held on October 1 at Weber's Pet Supermarket with over 90 walkers and their pets. The cute t-shirt was designed by George Mason University graphic art student Juliana Haley and it was a big hit with the walkers. Sponsors Becky's Pet Care, Dulles Health & Rehab Center, Regional Veterinary Referral Center, and VCA

SouthPaws Veterinary Specialists & Emergency had information tables and giveaways for the walkers.

There was a raffle drawing for door prizes for

all registrants and two \$50 Weber's Pet Supermarket gift certificates purchased for walkers who brought in pledges or donations to FPOW. One was given to Cynthia Underwood who brought in the most pledge money -- for the second year in a row -- and the other gift certificate was given to the winner of a random drawing among the other walkers with pledges or donations money.

Paws for a Cause is FPOW's only fundraiser which provides funding for insurance, paperwork, and volunteer appreciation. It is essential for FPOW's bottom line. Many thanks to everyone

Our strong partnership has afforded FPOW volunteers the greatest gift a passionate pet owner could ever hope for, the ability to share our beloved best friend with others and opportunity to give back to our amazing community.

# Report on the State of FPOW 2016—2017

Fairfax Pets On Wheels, Inc., had another very busy and successful 2016-2017 Program Year. We hit a milestone and celebrated our 30th year anniversary. During the year, through our allvolunteer organization, we continued the tradition of "helping to lick loneliness". We welcomed more than 48 new volunteer teams to our program during 2016-17. FPOW was honored by the Fairfax County Board of Supervisors who presented us with a Proclamation recognizing our contributions to the county and its residents. October 2017 was officially proclaimed as Fairfax Pets on Wheels Month. We thanked the Board of Supervisor's by presenting them with a U.S. flag that flew over the U.S. Capitol on May 30, 2017 in honor of our current and continuing partnership to continue to "lick loneliness" in our community.

Throughout the year we contributed more than 5,000 hours of pet visitation to 14 long-term care facilities and three Adult Day Health Care Centers under the auspices of the Fairfax Area Agency on Aging. The residents and senior clients truly enjoy our visits. Thanks to the staff of the Fairfax Area Agency on Aging Volunteer Solutions and the Ombudsman Program. FPOW's partnership with

the Agency has allowed our volunteers to bring meaningful interactions with the residents of the facilities we serve.

FPOW's United Way application was once again accepted for inclusion in the United Way of the National Capital Area Campaign – remember to designate #8907 when pledging. FPOW was also in the Combined Federal Campaign (CFC; #51148). Fundraising through United Way and CFC is crucial to FPOW's bottom line in allowing us to remain a successful program.

The Speakers' Bureau continued their monthly New Volunteer Orientation presentations reaching more than 115 potential volunteers. In addition, the Speakers' Bureau made presentations and/or staffed information tables at the Women's Club of Fairfax, Reston Pet Fiesta, Ventures into Volunteering, Shenandoah University and the Senior Saints at Holy Comforter.

FPOW's 22nd Annual 3k Paws for a Cause dog walk was in October 2016 and more than \$6,800 was raised. It was a beautiful day for a walk with more than 160 walkers and their pets in attendance. Special thanks to Madelynn Arnold for once again organizing this fun event.

On September 10th, we celebrated FPOW's 30th Anniversary year at Barrel Oak Winery in Delaplane, VA. We had over 120 in attendance. Many thanks to Jill Davidson and her team of helpers for its success for making our Anniversary so special. In addition, Carina Thornton of Fuzzypants Pet Photography took great photographs and pet portraits. At the event, FPOW recognized eight volunteers for giving between 50 and 74 hours to the program (Bronze Award), five volunteers for giving between 75 and 99 hours to the program (Silver Award), and 14 volunteers for giving more than 100 hours to the program (Gold Award).

There were also nine teams recognized for receiving American Kennel Club Therapy Certification. Winner of the Latshaw Award for Excellence was Denise Kloeppel. The Shauna Award went to Harley Bryson. Thanks to the Awards Committee

 Doreen Peters, Terry Carroll and Diane Ehrig for selecting winners from many deserving nominees.
 Thanks again to everyone who had a part in making this event special.

FPOW continues its partnership with the AKC Therapy Dog Titling program. Two received the Therapy Dog Advanced Title. All dogs – purebred and mixed breed – are eligible to earn the Therapy Dog titles. Also, it is important to note that AKC allows all dogs that hold AKC Therapy Dog titles (who are registered with FPOW, a recognized therapy organization, and have completed at least 10 therapy visits) to apply for AKC's Canine Good Citizen (CGC) title with no further CGC testing.

Karen Beekman did an outstanding job in updating our existing Merchandise website by revising our system for ordering FPOW merchandise using Square, an e-commerce provider to link our website for selling merchandise. The benefits were instant as the website shows items, tracks inventory, provides immediate notification of any item that is not available for purchase and collects immediate payment via credit (no more antiquated checks!). In addition, Karen designed and ordered new FPOW bandanas for our volunteer pets to wear proudly and created a new FPOW logo patch to enable members to order pet vests from ActiveDogs.com for their pet teammate.

The Board of Directors reviewed and updated 15 policies and procedures. This is a tedious exercise, but doing so is vital in keeping FPOW on point.

Ruth Benker, Director, Facility Relations, met with many of our Facilities to review the volunteer agreements and trained a new Facility Liaison for our new Dulles Rehab and Nursing facility. The facility liaisons provide the critical link between our program and our facilities; each facility has its own set of challenges and circumstances that are unique in providing pet visitation to its residents. Our liaisons are always willing and able to do what it takes to offer our services to the residents and help our volunteers meet the challenges of visiting.

The Temperament Testing Committee members

continue to have a full plate, making sure that every pet that becomes an FPOW volunteer has the ability to be an ambassador for our program. The testing team members have to be incredibly diplomatic when letting a potential volunteer know that his/her pet simply does not have what it takes to be an FPOW volunteer. There were approximately 97 teams tested and of those 80 teams passed the temperament test.

There are always so many people to thank for making FPOW successful with their devoted efforts. One group that deserves special recognition is the staff in the FPOW office — Ruth Benker, Madelynn Arnold, Jill Davidson, Joan Violante, Carla Graham, and Terry Carroll. Their ongoing dedication to the many tasks and all the paperwork that make our program happen are essential to the continued success of FPOW. Their continued contribution and dedication is crucial as they quietly and continually provide numerous hours to the program behind the scenes.

To all volunteers who serve on our various committees, (Merchandise, Office, Speakers' Bureau, Paws for a Cause, 30th Anniversary celebration, Temperament Testing, Nominating, Annual Photo Fund Raiser), we are very thankful that you have stepped up to the plate and remain grateful for all you do.

I would also like to thank the 2016-17 Board of Directors, who have helped me along in my first year as President of the Board. The Board was always willing to help with the many tasks involved in running the program with more than 170 volunteers both two- and four-legged. The Board was able to move FPOW forward and continue to meet new challenges. Special thanks to Ruth Benker and Madelynn Arnold for keeping me on track!

However, I would like to put a call out for additional volunteer

support on the Board and in other areas. As we all know, FPOW is an all-volunteer organization and the more hands the better. We could use help with Special Events Coordination, Temperament Testing, Newsletter, Fund Raising, Board Membership, Photography, Graphic Arts and Website administration. Any other talents you have that you could contribute would be welcome! Finally, thanks to you, our volunteers who make time in your busy lives to reach out to the residents.

You are not always aware of the good that you are doing by taking time to visit with your pet. Fairfax Pets on Wheels is truly a wonderful way to share your pet's love with other people.

As FPOW celebrates our 30th Anniversary we face new challenges, but we are well-poised to continue to grow, serve, and meet the challenges ahead. Our program is a bright shining light and is a testament to what works when like-minded people and their pets step up to serve the community.
