Volunteer Spotlight: Debbie Zelten

Our spotlight is on the recent Latshaw Award winner, long-time FPOW volunteer Debbie Zelten. Debbie has been a volunteer with FPOW since late 1996. Over the past 18+ years, she has had five different Bouvier des Flandres (literally Cow Herder of Flanders) in the Fairfax Pets On Wheels program. She got her first Bouvier in 1992 and fell in love with the breed and has had them ever since. Debbie says that she can't imagine life without at least one "hairy face" — also known as "dirty beard" — also known as a Bouvier. She has had at least one, usually two and sometimes three Bouviers at one time! At one point, Debbie briefly had three of the dogs certified with FPOW at the same time!

Debbie became acquainted with FPOW in 1995 when she was visiting a resident at Powhatan Nursing Home. She saw Fairfax Pets On Wheels volunteers visiting at Powhatan and thought that that was something she would enjoy doing with her dogs. She had two dogs at that time and had Kachia, the more social and out-going one, tem-

perament tested and she passed with flying colors. Unbeknownst to Debbie, the evaluator who did Kachia's test was not very fond of Bouviers. After the T-Test she confided in Deb that Kachia was so sweet, lovable and well-mannered that she couldn't help but like her and that changed her overall opinions of Bouviers. Kachia was a great ambassador for her breed.

Debbie and Kachia's adventures with FPOW began in December 1996 and Debbie has never looked back. She has been visiting with her bouvs at Powhatan since



that time and she started visiting at Vinson Hall Arleigh Burke Pavilion when FPOW began visiting there several years ago. She is now the FPOW Liaisons for both Powhatan and Vinson Hall. She trains and orients new FPOW volunteers at those two facilities along with the alternate liaisons at the two facilities.

Kachia was blonde in color — most Bouvs range in color from black to gray to silver — but they also are blonde or fawn in color. She was extremely smart, very social, and loved everybody. Debbie would call her my "Blonde Bimbo Princess" because while she was extremely smart, she could play the "dumb blonde" so well too, but it was all an act. She could work a room of people like a politician. She just "knew" that everyone was there to see and pet her so she would go around the room seeking attention, shaking "paws" and bringing smiles to all whom she met. Kachia was an FPOW volunteer until her death in August 2003.

Deb's second FPOW volunteer pet was Ripley. She was a big, smart, loveable grey girl with a goofy side to her as well. She too was a favorite at Powhatan. She did a number of tricks, one of which was the "bouvier bounce." Many Bouviers have a habit of jumping straight up into the air when they are happy, and Debbie taught Ripley to "bounce" on command. She could jump almost 5 feet straight up from a standstill — she'd jump straight up and try to give Deb a "kiss" on the way down. Ripley was in FPOW from 2002 until she died in October 2007.

Debbie's third Bouvier in the program was Bacal. She was a medium sized grey Bouvier who was the sweetest and most laid back Bouvier that Debbie ever had. She joined FPOW in 2004 and was sometimes used as the "neutral dog" for FPOW Temperament tests. Debbie used her when training new FPOW volunteers and their pets at both Powhatan and Vinson Hall. She'd help the "newbies" learn how to be therapy dogs (or cats). She was in FPOW until her death in November 2013.

The fourth Bouvier that Debbie had in the program was Jaleah, she was only in the program for about



a year and a half as Debbie was training her to be a companion and therapy dog for a couple living in North Carolina. Jaleah was a petite little black Bouvier who only weighed 57 pounds full grown (most female Bouviers are between 65 and 85 pounds). She was a delightful little girl that brought many smiles to residents of Powhatan Nursing Home for the brief year she was part of FPOW before moving on to her home in NC. Debbie's current FPOW volunteer partner is Bouvier is Jumoke. She is a black Bouvier who has been in FPOW since the summer of 2008. She helped train many new FPOW volunteer teams and brought joy into the lives of many residents at both Powhatan and Vinson Hall.

Debbie was born in Texas when her father was stationed there in the Army but she grew up in Wisconsin. She is a graduate of the University of Wisconsin with a degree in Management Information Systems and is a bit of a computer geek. She has worked in Information Technology (IT) for more than 30 years. She lived in Austin, TX for five years after graduating from college and moved to northern Virginia in 1984 and has lived here ever since. Debbie is currently an IT consultant working for a company that does IT technology consulting for non-profit organizations, leagues and associations. Debbie loves the outdoors and does lots of things with her husband and dogs. They enjoy hiking, biking, camping, fishing, swimming, boating, kayaking, etc. They own a log cabin on a

river in the Upper Peninsula of Michigan and spend as much time there as possible. They plan on having their summer home there when they retire.

Debbie feels that FPOW is a way to give of herself and share her dogs with people confined to nursing homes or assisted living facilities. Many of the people the team visit have few visitors or relatives who visit them, so they brighten the residents' sometimes lonely days. Debbie has had elderly relatives in assisted living or nursing homes and those facilities encouraged families to bring in their well-behaved pets, although these facilities did not have formal pet therapy programs like FPOW. But it is

not just the residents of the facilities that enjoy the pet visits. It is also the staff and other visitors as well who enjoy the pets. The facility staff enjoy the pet visits as much as the residents some time and family visiting the residents also enjoy the friendly "fuzzy faces" too!

Debbie says that she knows that all of her Bouviers have loved visiting. She uses a special leash and collar that is only for FPOW visits and whenever she gets that leash and collar out of the closet, the dogs get all excited because they know they are "Going Visiting." She says that when she drives to either Powhatan or Vinson Hall, the is amazing that when they get to a certain place along the route, the dogs start doing a happy bark, whine or dance in the car because they know they are almost there and they want to go in and visit with the people.

Debbie's tips for a good visit include always trying to have a smile for people — this might be one of the only rays of sunshine some people see. Remember to bring your dog up to the side of a wheelchair — parallel to it — rather than straight in from the front so the animal doesn't get tangled

up with the person's feet in the wheelchair. Then the resident can just put their hand over the side of the chair rather than having to lean forward.

After serving as an FPOW volunteer for so long, Debbie has many memorable visits. She has two that stand out, the first one was with Kachia the team had just arrived at Powhatan and there was a woman in a wheelchair being pushed by another woman through the lobby as the team entered. The woman saw them and Debbie asked her if she would like her to bring Kachia over to see the woman in the wheelchair. She said yes. When Kachia came up to the wheelchair and the woman slowly

stretched out her hand and put it on Kachia's head and very quietly said "Hello, dog." For about two minutes she very slowly petted and stroked Kachia and then put her hand back in her lap. At this point, the woman pushing the wheelchair was in tears. She took Debbie aside and thanked Debbie profusely. Debbie said it was not really a big deal — that was why they were visiting at the facility. Then she told Debbie those were the first words her mother had spoken in the nine months she had been at Powhatan! She never spoke or interacted with the staff or even her daughter, but she had just spoken and petted Debbie's dog. She asked if the team would try and see her mother whenever they were at Powhatan and they made it a point to visit with the woman.

The second incident occurred at Powhatan also with Ripley. There was another woman they used to visit at Powhatan who loved dogs and was very fond of Ripley. She was pretty much confined to her bed and whenever they visited her she always tried to get Ripley to jump up on the bed with her, which Debbie does not allow. (Debbie's dogs are not allowed on any furniture, anywhere!) Ripley was al-

most as large as the petite little woman herself! The resident had a running game whenever they visited - she would always call Ripley over and try to get her to jump up on the bed. Ripley knew it was not allowed and would look at Debbie and then always just laid her head on the bed next to the woman, who would pet and stroke her head and talk to her rather than Debbie. Well, one day, the team stopped into the woman's room, and of course she called Ripley and told her to get up on the bed with her. To Deb's surprise (and horror) Ripley jumped up on the bed and very carefully stretched out next to her. The woman (and Ripley) ignored Debbie telling Ripley to get off the bed. The woman just talked directly to Ripley and stroked her for a few minutes and then the woman told Ripley she could get down from the bed. So Ripley just "melted" off the side of the bed and came over to Debbie with a look that said "I just had to do it, Mom." The next week when they came for their visit the woman's room was empty. She had died a few days before. Debbie swears Ripley somehow knew it was her last chance to visit that woman and that was why she broke the rules by getting on her bed. It was the first and only time one of Deb's dogs ever got on a resident's bed.

In addition to being the Facility Liaison, Debbie has served on the Board of Directors for several years, as a Director at Large, as the Board Secretary, and currently as a Director of Volunteer Education. In her position as Director of Volunteer Education, Debbie is the FPOW Librarian and maintain the lending library of books, CDs and DVDs. She is the photographer who takes pictures of new volunteers at Temperament Tests for their badges and then pre-process the pictures each month for the badges and deal with the badge vendor.

FPOW is delighted that someone who loves Bouvier des Flandres and bringing joy to residents (and staff) of nursing homes and assisted living facili-

ties decided to volunteer and serve our organization for so many years. Congratulations to Debbie for winning a well-deserved Latshaw award.

Study: Cancer Patients Benefit From Therapy Dogs

"A first-of-its-kind investigation documented the impact of animal-assisted therapy on adult cancer patients.

Therapy dogs lifted the spirits of adult cancer patients by improving their emotional well-being and quality of life, according to research co-sponsored by veterinary drug manufacturer Zoetis Inc.

The clinical study, published this week in the Journal of Community and Supportive Oncology, involved patients receiving combined chemotherapy and radiation therapy for gastrointestinal, head or neck cancers."
