## State of FPOW 2012-2013

Fairfax Pets on Wheels, 26th year of “Helping to Lick Loneliness” began on a high note with the Fairfax County Board of Supervisors declaring October 2012 as Fairfax Pets On Wheels month in Fairfax County.

During the year, more than 4,800 hours were provided to 14 facilities by more than 300 volunteer teams. FPOW also began a pilot program to visit the five adult day care facilities that are under the auspices of the Fairfax Area Agency on Aging. These visits are conducted during the day in a group setting for the senior clients. More than 120 new volunteer teams have joined the program during 2012-2013.

FPOW’s United Way application was accepted for inclusion in the United Way of the National Capital Area Campaign – remember to designate #8097 when pledging. FPOW was also in the Combined Federal Campaign (CFC; #51148) and the Combined Virginia Campaign (#8098). Fundraising through United Way and CFC is crucial to FPOW’s bottom line, and some of this giving has been impacted by the sequester.

Speakers’ Bureau members made presentations at numerous United Way fundraising events and to Shenandoah University’s Spirituality in Patient Care class. In addition, the Speakers’ Bureau manned information booths at the National Capital Cat Expo, the Reston Pet Fiesta, the Annandale Fall Festival, and Northern Virginia Community College’s Green Festival. New publicity shots

were taken to use on the informational presentation board that is used at these events. FPOW was featured in articles in Cat Fancy magazine and the SunGazette newspapers.

FPOW's 17th annual 3K Paws for a Cause dog walk was held in October 2012 and more than \$8,500 was raised for the program. There were more than 150 walkers and their pets in attendance despite the blustery conditions on walk day. The 18th annual walk was held on October 6, 2013 and details are in this issue.

FPOW submitted an application to Discovery Communications in order to benefit from its 3rd annual "Creating Change" 12-hour marathon to benefit nonprofits. FPOW's "wish" on its application was to have a public service announcement (PSA) created that would air on local television stations in order to recruit new volunteer teams to our program. A team from Discovery Communications taped the PSA and other footage at Iliff Nursing Center in November. The high-quality results can be seen on FPOW's website.

Footage shot by Discovery Communications is now being used to develop FPOW's new Orientation video. FPOW is working with Kris Higgins of GoodbyeFilms to create a video that will be shown to prospective volunteers at our monthly Orientation sessions. The video that is currently being used is more than 20 years old and is really showing its age.

Kim Wilkerson, Director, Facility Relations, and the facility liaisons worked on streamlining the on-site process and reviewing the paperwork distributed to the new volunteers. Many of these documents had not been updated in quite a while and needed to be reviewed for procedures that had changed over the years.

In June, FPOW had its annual Volunteer Appreciation Picnic at Frying Pan Park in Reston. Many thanks to Kathi Baker, Director, Volunteer Appreciation, and her team of helpers for making the event so special. In addition to Kathi, Robin Burkett of PawPrints Photography took great pho-

tographs for our FPOW pet trading cards and pet portraits, King Creole Catering provided yummy food, and FPOW's DJ Michael Galvin provided the music and master of ceremony services. Liz Bryer provided a rally course again this year for our canine volunteers who chose to participate.

At the event, FPOW recognized 19 volunteers for giving between 50 and 74 hours to the program (Bronze Award), two volunteers for giving between 75 and 99 hours to the program (Silver Award), and 17 volunteers for giving more than 100 hours to the program (Gold Award).

Five volunteer teams were recognized for receiving American Kennel Club Therapy Certification. Winners of the Latshaw Award for Excellence were Jeanine Goldberg and Carla Graham, with past winner Patty Kwapniewski receiving an honorable mention for her service to the Temperament Testing Committee.

The Shauna Award went to three special pet volunteers – Abby Baker, Teddy Benker, and Gretel Powell. Thanks to the Awards Committee – Pat Leader, Tracy Van Duston, and Joan Violante – for selecting the winners from many deserving nominees. Thanks again to everyone who had a part in making this event special for the 116 human volunteers and 47 pets who attended.

FPOW was nominated for the first annual Booker Willoughby Service Award given by the Virginia/Maryland Regional College of Veterinary Medicine at Blacksburg, VA. The award recognizes the "intricate and special connection between animals and humans." The program was also nominated for Volunteer Fairfax's first annual recognition of volunteer groups that was presented at its annual volunteers' award breakfast. FPOW volunteers Ruth Benker and Kathi Baker were recognized by Volunteer Fairfax for their dedication to FPOW. Mt. Vernon Nursing and Rehabilitation Center recognized FPOW with a thank-you plaque for the program's work in the facility.

## Spotlight: Barbara Moskowitz

Barbara Moskowitz finds that being a volunteer for FPOW combines her love of greyhounds and

desire to advance greyhound education with her need to help others. She has also manned the FPOW booth at the National Capital Cat Show. She says that it is a privilege to volunteer for an organization that is run so well and with such good will.

Barbara was born in Brooklyn, New York, and raised by her maternal grandparents. This helps her feel completely at ease with the elderly. She moved to northern Virginia in 1983 with her husband Steve to further their careers with the federal government. The couple lives in Centreville with their two retired racing greyhounds, Millie and Airliner, and a Maine coon wannabee, Winkie. After

Barbara retired, she began to volunteer with Blue Ridge Greyhound Adoption and soon realized that Airliner would make a great therapy dog. Barbara found FPOW through an internet search and they have volunteered since 2009. Her son, Evan, is also certified as a FPOW volunteer.

Even though Barbara is experienced with visiting with the elderly, she had little or no experience interacting with Alzheimer's patients before starting to visit at Arden Court of Fair Oaks. She quickly learned that just to see the smiles on the residents' faces, a sudden brightening in their eyes, or the obvious pleasure some residents get from petting Airliner's warm, smooth fur is very gratifying. Barbara loves to answer the questions (usually the same one, "How old is he?") the residents ask over and over. Airliner and Barbara are a link to the outside world for many of these residents, and it's important for them to know that they have not been forgotten and still have worth. The visits are, very uplifting and help her keep life in perspective.

Airliner, for his part, loves all the attention and dutifully goes with Barbara from section to section in the facility to spread his love. The recreation room is his favorite, and is where he performs his best trick — standing patiently

watch him like a hawk. I monitor what he eats and how much. I provide a good, balanced diet, and I make sure he can't get to things that he shouldn't be eating. My goal is to keep him healthy and safe.

But the holidays can make that process difficult. For the last six to eight weeks of the year – and sometimes well into January – we party more, entertain more, and eat more than we do the rest of the year. Most of us worry about the effect of all that extra food and drink on our bodies. We also need to think about what a lot of extra food and treats will do to our dogs' bodies and to be extra vigilant about their diets.

We all know enough not to give our dogs alcohol or chocolate – but what about their favorite foods?

It's so easy. Faced with a mound of leftover turkey and a pair of pleading brown eyes, – well maybe I'll just

slip him a taste. Plus a little dressing. And a little cheese. Then after a holiday party – cocktail franks! More cheese! Christmas dinner here is always a big beef tenderloin. Quincy loves beef tenderloin. He also loves the almonds I put on the green beans. Oh, and some bacon from breakfast. And none of that is good for him, or for your dog, either.

I'm not opposed to giving my boy a special treat from time to time. And I especially like to give them when he's done something to earn them – a sit/stay, or a down/stay, for example. But as we come into the holidays, I begin to think carefully about exactly how often I do that, and about how much – and what – he's really eating. He doesn't appreciate this, of course. He'd much rather eat all of that leftover turkey. But I want to keep him here with me – safe and healthy – for a long time.

# Please Read: Important Information for All Fairfax Pets On Wheels, Inc. Volunteers

Dear Fairfax Pets On Wheels Volunteers:

Over the past few months, the FPOW Board of Directors and I have been working with the Fairfax Area Agency on Aging Volunteer Solutions Unit regarding new requirements that have been put in place by the State of Virginia for volunteers.

According to the Code, volunteers for Fairfax County must have background checks performed. **The County has given FPOW volunteers until the end of the year to complete this task.**

There are two places that volunteers can have fingerprints taken for the background checks.

The first is the Government Center located at 12000 Government Center Parkway, Suite 150, Fairfax, VA 703-324-4900. This office is open from 9:00 am to noon and from 1:00 & 3:30 pm.

The other location is at the South County Human Services Building at 8350 Richmond Highway, Ste. 407, Alexandria, 703-704-6075.

You must make an appointment and bring a completed copy of the Fairfax County Government Appointee Background Form and two forms of identification, including one with a picture. Visit [www.fpow.org/volunteer](http://www.fpow.org/volunteer) for all of the forms.

In addition, the County's Risk Management office is requiring FPOW volunteers to have a driver's record check. This is due to the fact that the County provides FPOW volunteers with secondary insurance while volunteers are driving to and from our facilities.

Please fill out the form, found here: [www.fpow.org/volunteer](http://www.fpow.org/volunteer), have your signature witnessed, and mail it back to Trina Mayhan-Webb, Volunteer Solutions, Fairfax Area Agency on Aging, 12011 Government Center Parkway, Suite 708, Fairfax, VA 22035.

I know that this is a major inconvenience for our volunteers. If you have any concerns regarding the background check and the driving record, please call the FPOW hotline at 703-324-5424 or contact the FPOW office at [dfspetsonwheels@fairfaxcounty.gov](mailto:dfspetsonwheels@fairfaxcounty.gov)

FPOW wants our volunteers to let us know about any problems they have with these new procedures in order to keep a record of these problems.

We will attempt to work with FAAA so that FPOW does not lose any of our valuable volunteers. FAAA might need to make other sessions available for FPOW volunteers to have the fingerprinting completed.
