

This custom is conducted primarily at churches across the country each year in celebration of St. Francis of Assisi's feast day.

State of the FPOW Program 2008–2009

Fairfax Pets on Wheels, Inc. saw another successful year during Program Year 2008 – 2009. In addition to our usual efforts at recruiting and training new volunteers, the following are features of the past year:

More than 8,000 hours of tail wagging and unconditional love were provided by over 300 volunteer teams to 12 long term care facilities having over 1,500 beds.

In spite of the downturn in the economy, FPOW's donations have grown. Our application was accepted for inclusion in the United Way of the National Capital Area campaign (designate 8907). We were included in the Combined Federal Campaign (designate 51148) and we were included in the Harmon Family Foundation's Catalogue for Philanthropy for 2008-2009 as one of the finest small charities in the Capital Area. We spoke at numerous United Way fund raising events and had information booths at Reston Pet Fiesta, Caring Hands Animal Hospital,

and National Capital Cat Show.

Lloyd Moore was the first recipient of FPOW's Founder's Award, a scholarship to be awarded annually to a vet tech or vet student pursuing education in honor of Kim Wilkerson. The second awardee of this scholarship is announced in this issue.

Earlier this year Kim Wilkerson was awarded WJLA's "Tribute to Working Women." This also came with a contribution which Kim donated to FPOW. In addition to Kim's award, WJLA produced a piece honoring her and FPOW which was featured by Alison Starling on WJLA's evening newscast. In April, three volunteers, Jill Davidson, Kathy Baker and Ruth Benker were recognized by Volunteer Fairfax for their outstanding contributions at a special breakfast at the Fairview Park Marriott.

In May, we had our Annual Volunteer Recognition Picnic at Lake Accotink for our volunteers – 110 humans, 65 pets – dogs and cats - in attendance. The weather this year cooperated and we awarded the Latshaw and Shauna Awards. The "Hours" pins were also given out.

We will be hosting Pat Miller to provide a seminar for our Temperament Evaluators. Thanks to Sabine Arndt and Patty Kwapniewski for their tireless work on launching this very exciting program. (See Dates to Remember)

We have begun, in conjunction with the FAAA Volunteer Solutions Unit, to review and evaluate the efficiency of current business processes. Ultimately, we want to be sure that our volunteers and potential volunteers are processed as quickly as possible through the combined efforts of FPOW volunteers and Volunteer Solutions staff.

FPOW was interviewed by Northern Virginia Magazine and was fea-

tured in their October issue.

Program year 2008-2009 has been my first year as the President of the Board of Directors of this amazing organization. I have some ideas to raise the visibility of the organization, which I would like to launch over the next program year. Our work in the community is important, our mission is to care for a population that is often given lip service but easily forgotten. I know I speak for many of us that we feel that we take more away from our visits as individuals. What could be more rewarding than sharing our beloved companions unconditional love with someone? This is the magic of what we do and what makes this organization thrive.

A Friend Indeed

Fairfax Pets on Wheels lost a huge supporter and friend in June when Kathie Schleede lost her battle with cancer. Kathie worked at the Fairfax Area Agency on Aging for 20 years and upon retirement volunteered in the office for FPOW.

Kathie was the “energizer bunny” in everything she loved or felt was her responsibility. The elderly were the population she chose to advocate for and she went above and beyond what her job required. Kathie was aware of the forgotten segments of this population one of those being the people who reside in nursing homes.

She was also concerned about another segment of the elderly and that was the deaf and hard of hearing. She learned sign language so she could converse with deaf and hard of hearing clients she had in the Volunteer Home Services program which she coordinated. And she took that further when she got involved with the Northern Virginia Resource Center for Deaf and Hard of Hearing (NVRC).

Kathie set up programs for them and arranged transportation which opened up many opportunities and resources for this population. In 2003 NVRC recognized Kathie for her advocacy and education efforts.

When the volunteer unit was between coordinators, Kathie took over the responsibility of the FPOW office work.



When I came onboard she was invaluable in getting me up to speed on how things worked.

Her favorite FPOW activity was the annual picnic. She made it to most of them but when she had a conflict she would say, “Do you think they would change the date so I can come?”

After graduating from the University of Akron with a B.S. in Geology, she taught science for a short time then took a job as administrative volunteer coordinator with the Girl Scouts.

After her daughters were born she became a full time mother but volunteered at the girls’ schools. She also

Mia her unusual name. Al & Mia visit residents at Commonwealth Care Center on a regular weekly basis, and what a team they are.

They joined the Fairfax Pets on Wheels program in July 2008 and during their one year of voluntary service have given over 84 hours of time to the delight of the Commonwealth residents and staff.

The Old English Sheepdog is a shaggy working breed developed in early 18th century England and used primarily in driving sheep and cattle to market. Mia Amica lives up to her breed's reputation as a working dog via her therapeutic visits with Al. She is a compact but large dog with a shuffling bearlike gait. Her unique, dense coat is weather resistant (meaning she is always ready for what Mother Nature delivers whether rain, snow or sleet) and long enough to cover her eyes.

However, don't be fooled – Mia Amica sees as well as any other of our canine friends and the hair over her eyes does not obscure her vision. When Al or his wife, Linda grooms her, her fur yields hair that can be made into a type of wool. The breed is frequently called "bob-tail" because its tail is removed soon after birth.

After Al retired, he was looking for interesting things to

do since he now had time to devote to personal interests. One day he browsed the Fairfax County website and came across the Fairfax Pets On Wheels webpage.

Al knew Mia Amica had the right temperament since she was friendly with all the neighbors on Norman

Street in Vienna, and especially all the kids in the neighborhood, who were drawn to Mia like bees to honey. And what a honey Mia has turned out to be. Al wanted to give something back to the community and voila --- he and Mia became volunteers in the program.

Al enjoys sharing Mia with everyone they meet. Al tells us "If one has a big ego and one is looking for 'a big take away,' then the FPOW program is not for you. Two-thirds of the people visited, do not know my name, but they never forget Mia Amica. All the residents know Mia." Our pets are the attraction for most of the elderly residents ---not us.

Al shares that at Commonwealth, news of their arrival appears to spread rapidly through the building. The residents all seem to know that Mia has arrived even before they enter the rooms. Mia has a special friend that always worries that Mia and Al would forget to visit her. No way! Mia Amica is too big to miss and of course their special friend always receives her visit with Mia and Al which never fails to make her day.

Al adds "FPOW is a neat program that gives you a chance to give back to the community. Remember, it 'ain't' about you. If you expect people to know you, forget it, but they sure know who Mia is."

A History of PAWS FOR A CAUSE

FPOW's first dog walk was held in 1996. It was a 5K walk and the event was held in October. The Board of Directors (BOD) liked Kim Wilkerson's suggestion that FPOW try a pet walk since the idea was so successful for the Baltimore Pets On Wheels program. The title Paws For a Cause was borrowed, with permission from the Montgomery County Pets On Wheels program.

The 1996 event was very successful and well attended. It's been known as the Paws For A Cause (P4C) ever since and has become "the" annual major fund-raising event.

The walk has been shortened to 3K to accommodate our many senior pets and volunteers.

Before the first walk in 1996, FPOW raised funds by conducting bake sales at local fairs and parades.

The BOD felt strongly that FPOW did not want to pester our volunteers with multiple fund raising events, nor spend too much of our time away from the residents and facilities that are the heart of our program mission.

Many factors have blended to make this event such a success. The primary key is that Madelynn Arnold has served as Chairman of the P4C committee every year, and what a wonderful job she has done. Madelynn is a master at organizing this day.

Another factor was the decision to seek

facility and business sponsors for the event and inviting their participation. Many of our dedicated sponsors continue to support P4C annually. It is a real joy to see our many facilities show their appreciation.

The long standing support and sponsorship of Weber's Pet Supermarket is yet another reason for P4C success. We owe a debt of gratitude to Weber's Pet Supermarket for serving as the primary sponsor for all our P4C events. Weber's has allowed us to use their Fairfax store location for the event, and also provides water bowls, doggie treats and biscuits for participating pets in the walks. Owners Deb and Roger Clark are long standing fans of FPOW, and their support and encouragement continues to inspire our program volunteers.

Special thanks to Weber's staff member Pam Koblitz, who deserves special recognition for her untiring efforts. She contributes her time on these special Sundays to arrange the logistical requirements that make our walks so successful.

The final key to success has been scheduling the event in early fall; the first Sunday in October continues to serve us well. The weather is beautiful at this time of the year --- not too cold and not too hot -- making it just right to get out for a walk with our pets.

Today the P4C event is 2nd only in total fund raising to the United Way and CFC campaigns.
