1. The specifications are broad and don't distinguish existing materials. Is the existing chilled water pipe steel or copper?

RESPONSE: During our site visit, the chilled water pipe was fully insulated and we were unable to determine the existing pipe material. The record documents by Korte Design, Inc., dated 3/6/98 specify pipe 2.5" and larger to be schedule 40 black seamless steel pipe and pipe 2" and smaller to be type L copper pipe.
