

Former LD29 Chair Lisa Everett's Disruptive Actions & False Allegations to Mislead PCs Must Stop

Dear LD29 Precinct Committeemen,

Once again, Lisa Everett is misleading our PCs with false and factually inaccurate statements (Please see Lisa's email below).

In her latest email, she claims that the LD29 bank account is "in violation" because it has only one authorized signer. That is not true.

Earlier this morning, I visited the bank personally. The bank manager confirmed that there is absolutely no issue with having a single authorized signer on the LD29 account. As Treasurer, I am the duly elected and legally responsible financial officer for LD29, and the account is in full compliance with both state law and our bylaws.

When I arrived at the bank (just five minutes before it opened), Lisa was standing at the door waiting for it to open. When she saw me park and walk toward the entrance, she quickly retreated to her car and drove away after cursing at me. She was aware that, having resigned as LD29 Chair earlier that morning, she no longer had any authority to close the LD's account or withdraw funds.

There was no reason for Lisa to attempt to close the LD29 bank account. The Treasurer—not the Chair—is responsible for maintaining all LD financial accounts and for submitting Treasurer's reports to the Secretary of State through the Beacon system.

For clarity, there is no bylaw, rule, or law that requires two signatures on the bank account or Beacon filings. If the Treasurer becomes unavailable, the funds and records can still be accessed and transferred properly.

Additionally, Lisa attempted to cancel the room reservation for our upcoming LD meeting on Thursday, November 20, 2025. Fortunately, the coordinator at the West Valley Republican and Independent Coalition declined her request, recognizing that it would have been unreasonable to

expect the new Interim LD Chair to secure an alternate meeting space on such short notice. Lisa did not inform Nickie Kelley, our new Interim LD Chair, of her resignation or the required Call Notice for the meeting that must be sent today to be timely. These actions were clearly intended to disrupt the transition and create unnecessary hardship for our district.

For the record, Arizona law (A.R.S. §16-905 and §16-926) and the Secretary of State's Beacon guidelines require only one designated Treasurer to manage and certify LD funds; having two signers is optional, not mandatory. Unfortunately, <u>Lisa is again misleading our PCs</u> by making factually inaccurate statements about bank procedures. Her attempt to dictate personal preferences on LD financial management — and to cancel our next LD meeting venue reservation after resigning — further demonstrates a deliberate intent to disrupt our transition and obstruct the orderly functioning of our district.

LD29 remains in full compliance with Arizona campaign-finance law and our bylaws. Our focus now is on moving forward, unifying our district, and restoring integrity, transparency, and respect to our leadership.

Dear PCs,

Once again, in Frank's zeal to attack me, he has violated policy. In my resignation letter, I stated that I would be closing the bank account and obtaining a cashier's check made payable to Nickie Kelley, First Vice Chair, which is the proper procedure.

When James Taylor resigned as Treasurer and Linda resigned as Chair, the account was properly closed and a cashier's check was held until a new account was opened.
